The "Veterans Party of Minnesota" has failed to file reports that accurately disclose all of the political committee's financial transactions in violation of Minnesota Statutes section 10A.20, subdivision 3 for the years 2017-2020. The committee is also in violation of Minnesota Statutes 10A.025 by knowingly providing false or incomplete information to the Campaign Finance Board, in violation of Minnesota Statutes 10A.17 for failure to disclose independent expenditures, and in violation of Minnesota Statutes 211B.04 for failure to use appropriate disclosures on political committee materials. Finally, the "Veterans Party of Minnesota" has non-disclosed expenditures that exceed their contributions, indicating that there are expenditures circumventing the reporting requirements in violation of Minnesota Statutes 10A.29.

Minnesota Statutes section 10A.022, subdivision 3, describes the procedures required for investigating complaints. A full description of the complaint process is available on the Board's website.

Briefly, the Board will notify you when it has received your complaint. The Board must send a copy of the complaint to the respondent. Complaints and investigations are confidential. Board members and staff cannot talk about an investigation except as required to carry out the investigation or to take action in the matter. After the Board issues a decision, the record of the investigation is public.

The law requires a complaint to go through two stages before the Board can begin an investigation: a prima facie determination and a probable cause decision. If the complaint does not pass one of the stages, it must be dismissed.

The Board has 10 business days after receiving your complaint to determine whether the complaint is sufficient to allege a prima facie violation of the campaign finance laws. If the Board determines that the complaint does allege a prima facie violation, the Board has 45 days to decide whether probable cause exists to believe a violation that warrants a formal investigation has occurred. Both you and the respondent have the right to be heard on the issue of probable cause before the Board makes this decision. The Board will notify you if the complaint moves to the probable cause stage.

If the Board determines that probable cause does not exist, the Board will dismiss the complaint. If the Board determines that probable cause exists, the Board will start an investigation. The Board will send you monthly updates regarding the status of the investigation. At the end of the investigation, the Board will offer you and the respondent the opportunity to be heard before the Board makes a final decision.

In most cases, the Board will issue findings, conclusions, and an order as its decision. For a spending or contribution limits violation, the Board can enter into a conciliation agreement with the respondent instead of issuing findings, conclusions, and an order. The Board's final decision will be sent to you and posted on the Board's website.

Complaint for Violation of the Campaign Finance and Public Disclosure Act

The “Veterans Party of Minnesota” has failed to file reports that accurately disclose all of the political committee’s financial transactions in violation of Minnesota Statutes section 10A.20, subdivision 3 for the years 2017-2020. The committee is also in violation of Minnesota Statutes 10A.025 by knowingly providing false or incomplete information to the Campaign Finance Board, in violation of Minnesota Statutes 10A.17 for failure to disclose independent expenditures, and in violation of Minnesota Statutes 211B.04 for failure to use appropriate disclosures on political committee materials. Finally, the “Veterans Party of Minnesota” has non-disclosed expenditures that exceed their contributions, indicating that expenditures are circumventing the reporting requirements in violation of Minnesota Statutes 10A.29.

Factual Background:

The “Veterans Party of Minnesota” is a political committee registered with the Minnesota Campaign Finance Board, registration number: 41178, first registered on 6/6/2017.

The Veterans Party of Minnesota has spent at least \$936 on Facebook ads between May 7, 2018, and May 16, 2021. There is evidence of advertising spending before May 7, 2018, but Facebook does not disclose the amount spent. (Exhibit 01)

The Veterans Party of Minnesota has maintained a website at <https://vpomn.org/> since at least June of 2017 according to www.archive.org.

The Veterans Party of Minnesota hosts its website on GoDaddy.com, which has hosting plans starting at \$8.99 per month.

The Veterans Party of Minnesota’s mailing address of 4707 Hwy 61 N Ste: #113 White Bear Lake, MN 55110 is a mailbox service of UPS Store #3299 and the committee has used this address since (at least) their initial filing with the Minnesota Secretary of State’s office on 7/15/2016. (Exhibits 02, 03)

The 2017 year-end Campaign Finance Board report for the “Veterans Party of Minnesota” shows \$130 in receipts (non-itemized) and \$70 in cash expenditures (non-itemized). Leaving an ending cash balance of \$60.

The 2018 year-end Campaign Finance Board report for the “Veterans Party of Minnesota” shows \$489.84 in cash receipts (non-itemized) and \$50 in cash expenditures (non-itemized). Leaving an ending cash balance of \$449.84.

The 2019 year-end Campaign Finance Board report for the “Veterans Party of Minnesota” shows \$771.11 in cash receipts, \$350 in contributions to candidate committees (undisclosed), \$255 in cash expenditures for “Membership Card Printing “, and \$30 in non-itemized expenditures. Leaving an ending cash balance of \$665.95.

The 2020 year-end Campaign Finance Board report for the “Veterans Party of Minnesota” shows \$170 in cash receipts (non-itemized), and \$0 in expenditures. Leaving an ending cash balance of \$835.95.

The Veterans Party of Minnesota has never disclosed any in-kind donations.

The Veterans Party of Minnesota has never disclosed any independent expenditures.

The Campaign Finance Board’s “Political Committee and Political Fund Handbook” is available to all political committees for guidance on accurate filing of reports. Included in the handbook is guidance on donations to candidate committees and states that the disclosure report “must include on any contribution made by the committee or fund.”

Violations of Minnesota Law:

The Veterans Party of Minnesota has never disclosed any expenditures related to advertising, or website hosting, website management, UPS mailbox services, or any other operational expenses on their disclosure reports. This is a violation of Minnesota Statutes 10A.20, subdivision 3.

Based on their Campaign Finance Board reports, The Veterans Party of Minnesota has raised insufficient money to account for the advertising expenses on Facebook alone, let alone other expenses. Circumvention of reporting contributions on behalf of a political committee is a violation of Minnesota Statutes 10A.29.

In their 2019 year-end report, the Veterans Party of Minnesota failed to disclose the recipients of \$350 in direct contributions to candidate committee in violation of 10A.20.

The Veterans Party of Minnesota's website and social media accounts do not contain the required disclosure under 211B.04. (Exhibits 03, 04, 05)

On October 13th, 2018, HutchisonLeader.com published a paid letter submitted by Antonio Nerios IV, state director of the Veterans Party of Minnesota, formally endorsing Dave Sebesta for Hutchinson City Council Seat 2. This independent expenditure was never disclosed in campaign finance reports in violation of Minnesota Statutes 10A.17 and does not contain the required disclosure under 211B.04.

On February 29th, 2020 Antonio Nerios IV, state director of the Veterans Party of Minnesota, signed a letter formally endorsing Chad Enstad for the 7th Congressional District of Minnesota. This independent expenditure of printing and distribution was never disclosed in campaign finance reports in violation of Minnesota Statutes 10A.17 and does not contain the required disclosure under 211B.04.

On October 21st, 2020, HutchisonLeader.com published a paid letter submitted by Antonio Nerios IV, state director of the Veterans Party of Minnesota, formally endorsing Brandon Begnaud for Hutchinson City Council Seat 3. The letter ended by saying "This letter was paid for by the Veterans Party of Minnesota." This independent expenditure was never disclosed in campaign finance reports in violation of Minnesota Statutes 10A.17 and does not contain the required disclosure under 211B.04.

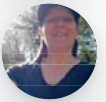

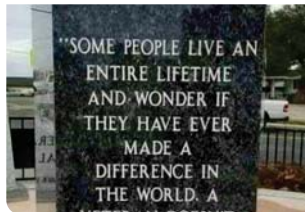

PAID ELECTION LETTER: Veterans Party of Minnesota endorses Sebesta


