

Minnesota Statutes section 10A.022, subdivision 3, describes the procedures required for investigating complaints. A full description of the complaint process is available on the Board's website.

Briefly, the Board will notify you when it has received your complaint. The Board must send a copy of the complaint to the respondent. Complaints and investigations are confidential. Board members and staff cannot talk about an investigation except as required to carry out the investigation or to take action in the matter. After the Board issues a decision, the record of the investigation is public.

The law requires a complaint to go through two stages before the Board can begin an investigation: a prima facie determination and a probable cause decision. If the complaint does not pass one of the stages, it must be dismissed.

The Board has 10 business days after receiving your complaint to determine whether the complaint is sufficient to allege a prima facie violation of the campaign finance laws. If the Board determines that the complaint does allege a prima facie violation, the Board has 45 days to decide whether probable cause exists to believe a violation that warrants a formal investigation has occurred. Both you and the respondent have the right to be heard on the issue of probable cause before the Board makes this decision. The Board will notify you if the complaint moves to the probable cause stage.

If the Board determines that probable cause does not exist, the Board will dismiss the complaint. If the Board determines that probable cause exists, the Board will start an investigation. The Board will send you monthly updates regarding the status of the investigation. At the end of the investigation, the Board will offer you and the respondent the opportunity to be heard before the Board makes a final decision.

In most cases, the Board will issue findings, conclusions, and an order as its decision. For a spending or contribution limits violation, the Board can enter into a conciliation agreement with the respondent instead of issuing findings, conclusions, and an order. The Board's final decision will be sent to you and posted on the Board's website.

Nature of Complaint

On or about January 18, 2018, the Libertarian Party of Minnesota ("LPMN") created a GoFundMe fundraising campaign page ("GoFundMe page") in support of Candidate Emily Mellingen ("Candidate Mellingen"). The GoFundMe page is available at http://www.gofundme.com/HelpEmilyWin. Attached for your convenience are screenshots of the GoFundMe page as it appeared on January 31, 2018 at approximately 10:00 a.m.

To date, the GoFundMe page has raised \$1,054 from 20 contributions (ranging from \$5 to \$225) and seeks to raise an additional \$13,520 in order to meet the fundraising goal of \$14,574. The LPMN seeks to raise this amount to pay for campaign brochures and telemarketing services.

The express purpose of the GoFundMe page is funnel the raised funds to Candidate Mellingen. Specifically, the page states: "This GoFundme [sic] page was created by the LPMN and to be clear donations will be going to the candidates [sic] (Emily) campaign comittee [sic]".

On information and belief, Candidate Mellingen and the LPMN have committed violations of Minnesota campaign finance laws through the use of this GoFundMe page, including, but not limited to, the following laws:

- Minn. Stat. § 10A.16 for the LPMN's express acceptance and solicitation of earmarked contributions;
- Minn. Stat. § 10A.29 for Candidate Mellingen and the LPMN's circumvention of campaign finance laws through the use of the GoFundMe page; and
- Minn. Stat. § 211B.04 for the LPMN's failure to include the required disclaimer on disseminated campaign material.

LPMN is in violation of Minn. Stat. § 10A.16 for earmarking contributions.

- 1. On information and belief, the LPMN violated Minn. Stat. § 10A.16 for accepting and soliciting contributions through the GoFundMe page with the express or implied condition that the contributions will be directed to Candidate Mellingen.
- 2. On information and belief, the LPMN knowingly accepted earmarked contributions.
- 3. The LPMN expressly states that contributions made to LPMN via the GoFundMe page will be earmarked for Candidate Mellingen: "This GoFundme page was created by the LPMN and to be clear donations will be going to the candidates (Emily) campaign comittee."

Candidate Mellingen and LPMN are in violation of Minn. Stat. § 10A.29 for circumventing various provisions of Chapter 10A.

- 4. On information and belief, Candidate Mellingen and the LPMN violated Minn. Stat. § 10A.29 by circumventing recordkeeping requirements and prohibitions against accepting anonymous contributions.
- 5. Individuals making donations to a GoFundMe campaign have the option to make the donation anonymous to the public. If made anonymously, GoFundMe hides the name of the donor from public view on the GoFundMe page. However, whether or not made anonymously, the Campaign Organizer will always receive and have access to the following information: donor's name, donor's email, donation amount, and donation comment.
- 6. GoFundMe does not distribute, publish, or otherwise make available a donor's address or employer/occupation.
- 7. Minn. Stat. § 10A.13 requires party units and campaign committees to keep account of various campaign finance records, including, specifically, the name, address, amount, and date of each contribution in excess of \$20.
- 8. Minn. Stat. § 10A.15 makes it a violation to retain an anonymous contribution in excess of \$20.
- 9. Minn. Stat. § 10A.20 requires party units and campaign committees to report—in addition to the information required in Minn. Stat. § 10A.13—the employer or occupation of any contributor that in the aggregate contributes more than \$200 in a year.
- 10. In order to comply with Chapter 10A, LPMN must follow up with GoFundMe donors and obtain the addresses for those individuals that contributed in excess of \$20 and employer/occupation information for those individuals that contributed in aggregate and in excess of \$200 in a year otherwise those donations must be treated as anonymous contributions.
- 11. On information and belief, the LPMN does not have the required addresses and/or employer/occupation information of the GoFundMe donors and the LPMN has yet to obtain such information. Consequently, all contributions in excess of \$20 made to the GoFundMe page are anonymous contributions.

- 12. As of January 31, 2018, 15 of the 20 contributions made through the GoFundMe page are in excess of \$20.
- 13. As of January 31, 2018, 1 of the 20 contributions made through the GoFundMe page are in excess of \$200.
- 14. On information and belief, the LPMN has retained such anonymous contributions by transferring the contributions to Candidate Mellingen.
- 15. By retaining and subsequently contributing the anonymous GoFundMe contributions to Candidate Mellingen, the LPMN and Candidate Mellingen have knowingly circumvented various provisions of Chapter 10A, including, but not limited to, Minn. Stat. §§ 10A.13, 10A.16, 10A.20.

LPMN is in violation of Minn. Stat. § 211B.04 for failure to display required disclaimer on disseminated campaign material.

- 16. On information and belief, the LPMN violated Minn. Stat. § 211B.04 for preparing and disseminating campaign material that does not prominently include the name and address of the person or committee causing the material to be prepared or disseminated in a disclaimer substantially in the form provided in Minn. Stat. § 211B.04(b)-(c).
- 17. The GoFundMe page contains campaign material, as defined at Minn. Stat. § 211B.01, subd. 2, because the page contains material that is disseminated for the purpose of influencing voting at an election: (1) the page advocates for the election of Emily Mellingen to Minnesota State Senate; and (2) the page identities the office and election date.
- 18. The GoFundMe page identifies the creator of the page as the "Libertarian Party of MN" and as the "LPMN," however, the page does not provide the address for the LPMN.
- 19. The GoFundMe page does not state or otherwise indicate that the page was "Prepared and paid for" by the LPMN, as required by Minn. Stat. § 211B.04, subd. b.
