COMPLAINT

- This action arises from unlawful corporate campaign contributions, in violation of Minn. Stat. § 211B.15, made by Action 4 Liberty, a registered 501(c)(4) organization, to the Neil Shah for Governor Campaign. Exhibit A.
- 2. In 2021, Action 4 Liberty actively fundraised for the Shah for Governor campaign. Additionally, on multiple occasions, Action 4 Liberty provided the Shah for Governor campaign with its "digital backbone" (permitting the campaign to actively campaign on-line) free of charge.

FACTS

- 3. Based on information and belief, the Complainant, Matt Werden, adopts all allegations set forth in this Complaint.
- 4. Action 4 Liberty ("A4L") is a registered 501(c)(4) located in the State of Minnesota.

 Exhibit A.

- 5. A4L's mission is to "protect liberty for the next generation." A4L implements this mission by recruiting "pro-liberty candidates for the legislature and equip[ing] them to win their elections."
- 6. A4L controls a political action committee (the "A4L PAC") registered with the Minnesota Campaign Finance and Public Disclosure Board. **Exhibit B.**
- 7. Dr. Neil Shah for Governor ("Shah for Governor") is a candidate committee registered with the Minnesota Campaign Finance and Public Disclosure Board. **Exhibit C.**
- 8. Dr. Neil Shah has been a candidate for Governor since August 3, 2021.
- 9. Based on information and belief, in 2021, A4L has made illegal corporate contributions to Shah for Governor.
- 10. Starting on or about August 6, 2021, Shah for Governor sent fundraising e-mails containing links that share a domain with A4L. **Exhibit D.** ²
- 11. In Shah's e-mail, a donation icon provided a hyperlink taking users to a donation page. The donation link was a A4L link routing users through a A4L domain to a Shah donation page. Other links, such as the heading and volunteering links, also route users through A4L domains. **Exhibits D-1 and D-5.** The presence of all the A4L links shows that it furnished Shah for Governor with the web-based means to engage in direct fundraising and other campaign-related activity.
- 12. On or about August 3, 2021, A4L sent out an e-mail endorsing Dr. Shah's campaign. **Exhibit E.** Within this e-mail, there was a link to Shah for Governor's website. This link is another A4L link that routes users through a A4L domain directly to Dr. Shah's

- website. **Exhibits E-1 and E-3.** Subsequent to the August 3, 2021 email, A4L sent out at least three other e-mails endorsing Dr. Shah. The bottom of each e-mail states that the e-mail was "Created with NationBuilder, software for leaders." **Exhibit F**.
- 13. Following the A4L endorsement on August 3, Shah for Governor sent out emails on August 6, September 9, September 15, September 28, October 6, October 10, October 14, and November 3, 2021. Each of these emails contained embedded A4L hyperlinks, demonstrating that the "backbones" of these web-based services were all product of A4L's efforts. Additionally, all the Shah e-mails state that they too were "Created with NationBuilder, software for leaders." **Exhibits D and G.**
- 14. The Shah communications additionally evince that A4L is providing Shah with its membership email lists and/or access to its membership, in addition to the fundraising links previously provided by A4L.
- 15. Close examination of the hyperlink attributes shows that all of the communications, from Dr. Shah and from A4L, are using the same internet domain, Urchin Tracking Module Parameters, and identifiers. These unique features are identifiers used to show who is responsible for creation and control of the domains.
- 16. Therefore, because the hyperlinks in Dr. Shah's emails contain the same A4L identifiers (also the same identifiers used by A4L in its communications), this shows that they were:
 - a. created by or for A4L,
 - b. controlled by A4L,
 - c. paid for by A4L, and
 - d. utilized by A4L and Shah for Governors for Shah's specific and exclusive use.

- 17. None of the emails contained in Exhibits D, E, F, or G indicate that the A4L PAC was responsible for the communication (or that the communication was an independent expenditure). It is indisputable that the communications were from A4L, the 501(c)(4) entity, as the communications were done by, through, and directly linked to the A4L 501(c)(4) entity's website. *See* Exhibits D-1, E-1, F-1, F-5, F-8, G-1, G-6, G-11, G-16, G-21, G-26, and G-32.
- 18. Expenditures and contributions must be reported in the year they are made. Minn. Stat. § 211A.02; Minn. Stat. § 10A.01, subd. 9.
- 19. The A4L PAC did not report any contributions or expenditures during the whole of 2021 or in its April 2022 1st Quarter Report. **Exhibits H1 and H2.**
- A4L PAC has reported various media-related expenses on its previous reports, in 2019.
 Exhibit I.
- 21. The A4L PAC did not report contributions for 2021 April 2022 1st Quarter Report. See Exhibits H1 and H2.
- 22. Shah for Governor has not reported any expenditures in 2021 for services provided by A4L or for any services provided by NationBuilder. **Exhibit J.**

VIOLATIONS OF LAW AND CLAIMS

- 23. Corporate political contributions are expressly prohibited under Minnesota law. Minn. Stat. § 211B.15, subd. 2. Under this statute, a "corporation" includes a nonprofit corporation. Minn. Stat. § 211B.15, subd. 1(2).
- 24. Minnesota law strictly prohibits a nonprofit corporation from making a contribution "of any money, property, free service of its officers, employees, or members, or thing of monetary value" to "promote or defeat the candidacy of an individual for

- nomination, election, or appointment to a political office." Minn. Stat. § 211B.15, subd. 2.
- 25. A contribution is "money, a negotiable instrument, or a donation in kind that is given to a political committee, political fund, principal campaign committee, local candidate, or party unit." Minn. Stat. § 10A.01 subd. 11(a).
- 26. A "donation in kind" is "anything of value that is given [...]" Minn. Stat. § 10A.01 subd. 13.
- 27. The Minnesota Campaign Finance and Public Disclosure Board has jurisdiction over this matter pursuant to Minn. Stat. § 10A.022, subd. 3(a).
- 28. The Minnesota Campaign Finance Board and Public Disclosure Board has previously concluded that the use of a website constitutes a contribution. The "use of a Web site without charge is a donation in kind" whose "fair market value will count both against the applicable contribution limits of the candidate and against the campaign expenditure limit of any candidate..." *See* Minnesota Campaign Finance and Public Disclosure Board, Advisory Op. 381 (May 16, 2006).
- 29. A4L's activity has gone far beyond simple website usage; it is using its online resources to actively fundraise for the Shah for Governor campaign. *See* Exhibit E. Additionally, it is providing the digital "backbone" for Shah for Governor to campaign for office, free of charge. *See* Exhibits D-1, E-1, F-1, F-5, F-8, G-1, G-6, G-11, G-16, G-21, G-26, and G-32. A4L is providing Shah for Governor with multiple and repeated illegal corporate contributions in violation of Minnesota law.
- 30. A4L's expenditures complained of herein constitute, at the VERY least, in-kind donations, and thereby contributions, to Shah for Governor in violation of Minnesota

- law. A4L has contributed goods and services of significant monetary value to Shah for Governor by furnishing Dr. Shah with digital services, digital material, and other webbased support that the candidate would otherwise have to pay for. See Exhibits D, E, F, and G.
- 31. A4L's expenditures were not independent because its links are incorporated in Dr. Shah's e-mails, and the links route users to Dr. Shah's official website. Therefore, there was implied or explicit consent to receiving the web services through incorporation of the services in Dr. Shah's e-mail.

RELIEF SOUGHT

- 32. Pursuant to authority conferred on the Board by Minn. Stat. §§ 10A. 022, subd. 3(a) and 211B.15 subd. 7(a), it may impose penalties "up to ten times the amount of the violation" if a nonprofit corporation illegally contributes to a campaign.
- 33. Additionally, pursuant to Minn. Stat. § 211B.15 subd. 7(b), a nonprofit corporation that "knowingly violates" Minn. Stat. 211B.15 "is subject to a fine not greater than \$40,000." A knowing violation occurs when the nonprofit corporation "at the time of transaction… knew (1) that the transaction causing the violation constituted a contribution under chapter 10A, 211A, or 383B; and (2) that the contributor was a corporation …"
- 34. The Complainant requests that this Board impose maximum fines pursuant to Minn. Stat. § 211B.15 subd. 7 for unlawful corporate contributions by A4L.
- 35. Additionally, Complainant requests that the Board refer the matter to the Washington County Attorney for prosecution.


