TAMN is a political party, consisting of 26 member organizations and thousands of individual members. However it is not registered with MN CFB as a political party. TAMN also supports radical and progressive activist groups throughout MN, as well as nationally. TAMN additionally sponsors organizations who are essentially political affiliates, but this fact can only be seen by looking at a great number of social media sites. TAMN also has also assisted numerous local organizations in the Twin Cities as well as Statewide, to essentially operate as satellite org's to TAMN. Almost all of these org's have 501C3 status. TAMN has also created organizations for short periods of time through which tremendous financial resources flow to. One such org. is Housing Equity Now St Paul (HENS), which did not register with the SOS, and did not file a tax return. The website for HENS has disappeared. TAMN has funded a very long list of initiatives for social change, which will be seen in my supporting documents. TAMN is an affiliate org. of People's Action (PA), a national coalition, and TAMN leadership operates at high levels in PA.

Minnesota Statutes section 10A.022 and Minnesota Rules Chapter 4525 describe the procedures required for investigating complaints. A full description of the complaint process is available on the Board's website. Briefly, the Board will notify you when it has received your complaint. The Board must send a copy of the complaint to the respondent. Complaints and investigations are confidential. Board members and staff cannot talk about an investigation except as required to carry out the investigation or to take action in the matter. After the Board issues a decision, the record of the investigation is public.

The law requires a complaint to go through two stages before the Board can begin an investigation: a prima facie determination and a probable cause decision. If the complaint does not pass one of the stages, it must be dismissed. The Board chair or their designee has 10 business days after receiving your complaint to determine whether the complaint alleges a prima facie violation. If the complaint alleges a prima facie violation, the Board has 60 days to decide whether probable cause exists to believe a violation that warrants a formal investigation has occurred. Both you and the respondent have the right to be heard on the issue of probable cause before the Board makes this decision. The Board will notify you if the complaint moves to the probable cause stage.

If the Board determines that probable cause does not exist, the Board will dismiss the complaint. If the Board determines that probable cause exists, the Board may start an investigation. In some cases the Board will issue findings, conclusions, and an order as its decision. In other cases the Board will instead enter into a conciliation agreement with the respondent. The Board's final decision will be posted on the Board's website.

TAMN has developed a methodology of organizing far in advance of the MN DFL Caucus, with their selected candidates highly trained and supported to win the DFL endorsement.

It seems unlikely that the DFL leadership is not aware that TAMN has increasingly been succeeding in getting their not only endorsed but winning in DFL primaries and elections.

TAMN endorsed candidates are essentially "Manchurian Candidates", and by 'looking the other way', the MN DFL leadership, which is based in St Paul, is complicit.

TAMN's network of radical organizations has been seeking, grooming, training, endorsing, and campaigning for candidates who they recruit, based upon the willingness of the potential candidate to work in partnership with TAMN.

MN voters who have long been loyal to the DFL are being cheated, because the vast majority of them are not aware that the radical agenda of TAMN is being enacted under the DFL party name.

TAMN also has national partners that assist as needed. In the 2020 election, Minnesota was regarded as a swing state, and resources from national coalition partners flowed into MN through TAMN, TAMN coalition member organizations, and TAMN subsidiary organizations.
