INTRODUCTION

That on 08/29/2024, Complainant did notice that around the Brainerd Lakes area, flyers were being prepared and disseminated by Respondent.

Respondent, it should be noted, fails to regularly use their registered name and instead on much of their propaganda, assert to be “Crow Wing County Republicans.”

That said flyers were titled, “Meet your Legislators, Elected Officials And 2024 Candidates”. That the flyers had a partial fundraising purpose, “Donations to candidates will be appreciated”. (Exhibit 1)

That of the “keynote speakers”, all were Republican, including arrested and charged sexual degenerate, Justin Eichorn. Not to be outdone, Pete Stauber and Glenn Gruenhagen, were there lying to the crowd of simpleton hypocritical fart sniffing boomer constituents about the terrorist state of israel.

That at the time, Complainant was running as an independent for the local State House seat. Complainant was notified of the flyers by numerous individuals asking if he was going to attend the event.

That upon this notice, Complainant inquired about the matter on Respondent’s Facebook page. In typical fashion from the party of “Uncensored free speech” and the “Constitution & Bill of Rights” (Exhibit 2), he was blocked and censored for his inoffensive speech (Exhibit 3). Complainant also noticed the BPOU of their woefully inadequate and dishonest “disclaimer” on the aforementioned flyers which intentionally misrepresented and dishonestly stated, “Not sponsored by any political organization or candidate”. These flyers failed to disclose who prepared and disseminated the flyers nor contained any name and address.

That censorship is regular with regard to the BPOU, including their golden child, Joshua Heintzeman, who admitted to censoring constituents expressing grievances on his “Official Facebook Page”. (18-cv-24-2821 Def. Motion Dismiss Memorandum)

That the Respondent’s “God and Government” BPOU officers regularly lie and cheat, even under oath along with their elected officials; typical of those that need to shield their corruption by espousing to be Christian instead of just living the Word. (Exhibit 4)

That on 08/30/2024, Complainant went to Respondent’s “Victory Office” located at 405 Washington Street, Brainerd, MN.

That Complainant spoke to a male volunteer at the office that confirmed that the BPOU was indeed preparing and disseminating the flyers. That the gentleman also pointed to a pile of flyers, fresh off the press of that morning, and stated, Deputy Chair, Donna Winge had replaced the formerly prepared and distributed flyers with.

That the new flyers were comically printed where Winge intentionally copied them in a way where the original disclaimer no longer showed at all...which not only doesn’t remedy the original violation, but now creates another violation as there is no disclaimer at all. (Exhibit 5)

That the flyer, as represented as Ex. 1, was also produced and disseminated on Respondent’s website on 08/30/2024 at,

In fact, it is still there at the signing of this complaint...it was clearly not only Respondent organizing the event, but they were clearly producing and disseminating the flyers.

That “Keynote Speakers” which were advertised that have a constituency in Crow Wing County at the time were Justin Eichorn, Ben Davis, Eric Klang, and Pete Stauber.

That Complainant attended the advertised 09/06/2024 event. First there, setting up the venue, was Donna Winge. She also set up a booth where she was distributing more propaganda, of which, were flyers titled, “Crow Wing County Republicans Supported Candidates” and other flyers advertising future events. (Exhibit 6)

In standard psychopathic entitled self-righteous degenerate boomer fashion, Winge aggressively confronted Complainant despite his peaceful demeanor and the fact that the event was open to the public. She admitted she was there in the capacity of the BPOU.

Clearly Winge was clearly upset that Complainant had discovered their subversive attempt at promoting the event.

Also, Respondent uses non registered addresses with their propaganda (Exhibit 2) which is deficient under law as stated “The address **must be** either *the committee's* mailing address...” which was displayed 06/15/2025-September 28, 2024 at their tent events (Exhibit 7)

CONCLUSION

It is clear that this county is full of disgusting degenerate sex, drugs and rock and roll boomercons that will stop at nothing to stay relevant; including destroying their grandchildren’s grandchildren’s future.
