#### **MINUTES**

The meeting was called to order by Chair Flynn.

Members present: Flynn, Haugen, Leppik, Moilanen, Rosen, Swanson

Others present: Sigurdson, Engelhardt, Pope, staff; Hartshorn, counsel

The meeting did not strictly follow the order of business set forth in the agenda.

MINUTES (January 9, 2018)

After discussion, the following motion was made:

Member Leppik's motion: To approve the January 9, 2018, minutes as drafted.

Vote on motion: Unanimously passed.

#### **CHAIR'S REPORT**

#### A. Meeting schedule

The next Board meeting is scheduled for 10 a.m. on Wednesday, April 4, 2018.

#### **EXECUTIVE DIRECTOR REPORT**

Mr. Sigurdson presented members with a memorandum regarding this matter that is attached to and made a part of these minutes. Mr. Sigurdson told members that a few more committees and individuals had filed their 2017 reports since he prepared his memorandum. Mr. Sigurdson said that staff would begin tracking the percentage of timely filers for each program and would use those figures to determine which outreach methods were the most effective. Mr. Sigurdson stated that the lobbyist program currently had the highest rate of timely compliance.

Mr. Sigurdson then introduced the new assistant executive director, Megan Engelhardt. Ms. Engelhardt told members that she had come to the Board from the Office of Lawyers Professional Responsibility where, among her other duties, she conducted investigations and prepared advisory opinions. Members welcomed Ms. Engelhardt to her new position.

Mr. Sigurdson next told members that Gary Goldsmith and Joyce Larson would be retiring on May 1, 2018. Members reported the numerous compliments that they had received regarding the work of Mr. Goldsmith and Ms. Larson and discussed the fact that both Mr. Goldsmith and Ms. Larson would be greatly missed.

#### SUPPLEMENTAL ENFORCEMENT REPORT

#### D. Waiver request - Citizens for Justice Anne McKeig

Ms. Pope told members that the Citizens for Justice Anne McKeig committee was asking the Board to waive a \$1,000 late filing fee incurred for an untimely registration. In the waiver request, the committee's treasurer, Eric Day, stated that when he was preparing the committee's 2017 year-end report, he realized that the committee had never actually registered with the Board when the committee was formed in October 2017. By the time that the committee actually filed its registration, it had accrued the maximum late filing fee. Ms. Pope said that the Board had not granted any prior waiver requests for the committee.

Committee treasurer Eric Day then addressed the Board. Mr. Day said that the committee had prepared a registration form when it initially organized and that he believed that he had filed that form with the Board. Mr. Day stated, however, that he never actually filed the registration form. Mr. Day said that he believes that he failed to file the registration, and mistakenly believed that he had done so, because he was under a great deal of stress at the time due to his father's terminal cancer diagnosis. Mr. Day said that he filed the registration form as soon as he discovered the error.

After discussion, the following motion was made:

Member Rosen's motion: To waive the \$1,000 late filing fee incurred by the

Citizens for Justice Anne McKeig committee for an

untimely registration.

Vote on motion: Unanimously passed.

During the discussion of the regular enforcement report, the following motion was made:

Member Rosen's motion:

To consider the waiver request submitted by the

Citizens for Justice Anne McKeig committee even though this matter was not placed on the agenda at

least seven days in advance of the meeting.

Vote on motion: Unanimously passed.

#### LEGISLATIVE RECOMMENDATIONS

Mr. Sigurdson presented members with a memorandum regarding this matter that is attached to and made a part of these minutes. Mr. Sigurdson told members that as directed at the November meeting, he had met with legislators and legislative staff to determine whether there was bipartisan interest in legislative recommendations from the Board. Members Leppik and Moilanen had attended some of these meetings. Mr. Sigurdson said that the reaction of the legislators generally had been positive and

that it appeared that members of both parties would be willing to author the legislation. Members then discussed the legislative proposals and the administrative rule proceeding.

After discussion, the following motion was made:

Member Leppik's motion:

That the Board adopt the following resolution:

Resolved, that the Campaign Finance and Public Disclosure Board affirms the legislative policy proposals outlined in the executive director's January 31, 2018, legislative recommendations memorandum and directs the Board chair to forward the recommendations to the appropriate legislative chairs.

Vote on motion:

Motion passed (four ayes, two nays).

#### AMENDED AFFIRMATIVE ACTION PLAN

Mr. Sigurdson presented members with a memorandum regarding this matter that is attached to and made a part of these minutes. Ms. Pope told members that the Board's 2016-2018 Affirmative Action Plan incorporated the language of the statewide sexual harassment prohibited policy but did not expressly adopt that policy. Ms. Pope said that in response to a directive from the Department of Management and Budget, the plan had been amended to expressly adopt the statewide sexual harassment prohibited policy. Ms. Pope stated that the plan also had been updated to name Mr. Sigurdson as executive director.

After discussion, the following motion was made:

Member Leppik's motion: To ratify the amended 2016-2018 Affirmative Action

Plan.

Vote on motion: Unanimously passed.

#### **ENFORCEMENT REPORT**

#### A. Consent items

#### 1. Confirmation of lobbyist termination – Sarah Janecek

Ms. Pope told members that after Board staff learned that Ms. Janecek had passed away on January 12, 2018, staff administratively terminated Ms. Janecek's lobbyist registration for Caribou MSP Airport effective December 31, 2017. Ms. Pope said that staff was asking the Board to confirm this administrative termination and to not require filing of the lobbyist disbursement report that was due on January 16, 2018.

#### 2. Confirmation of lobbyist termination – Tom Liebe

Ms. Pope told members Mr. Liebe's principal association, the Cooperative Network, had notified Board staff that Mr. Liebe had left his position with the organization on August 1, 2017. Staff then administratively terminated Mr. Liebe's lobbyist registration as of that date. Ms. Pope said that staff was asking the Board to confirm this administrative termination. Ms. Pope said that Mr. Liebe's lobbyist disbursements for 2017 were reported by the association's reporting lobbyist.

#### 3. Confirmation of lobbyist termination – Jenna Duwenhoegger

Ms. Pope told members that Ms. Duwenhoegger's principal association, the Nurse-Family Partnership, had notified Board staff that Ms. Duwenhoegger had left her position with the association on October 2, 2017, due to a departmental reorganization. The principal also stated that Ms. Duwenhoegger did not have any lobbyist disbursements during the last reporting period. Staff then administratively terminated Ms. Duwenhoegger's lobbyist registration as of October 2, 2017. Ms. Pope said that staff was asking the Board to confirm this administrative termination and to not require filing of the lobbyist disbursement report that was due on January 16, 2018.

## 4. Request to accept an unsigned lobbyist disbursement report and termination statement – Frank Forsberg and Greater Twin Cities United Way

Ms. Pope told members that the Greater Twin Cities United Way (GTCUW) was asking the Board to accept an unsigned lobbyist disbursement report and a termination statement from its former employee Frank Forsberg. The GTCUW explained that Mr. Forsberg had reviewed these documents before he retired on December 31, 2017, but had left the state before the final versions were ready for signature.

After discussion, the following motion was made:

Member Swanson's motion: To grant all requests on the consent agenda.

Vote on motion: Unanimously passed.

#### B. Discussion items

#### 1. Request to withdraw lobbyist registration – Sarah Walker

Ms. Pope told members that on February 8, 2018, Ms. Walker had registered as a lobbyist on behalf of the Veterans Resiliency Project. Within a week of registering, however, Ms. Walker had discovered an unexpected conflict of interest that would prevent her from lobbying for this principal. Ms. Pope said that Ms. Walker therefore was asking the Board to allow her to withdraw this lobbyist registration.

#### 2. Request to withdraw candidate committee registration – Wharton (Jeffrey) for Minnesota

Ms. Pope told members that Mr. Wharton had registered a committee for governor on March 20, 2017. In response to requests for a 2017 year-end report, Mr. Wharton had told staff that he no longer was running for governor and that he had not raised or spent any money during his campaign. Ms. Pope said that Mr. Wharton was asking the Board to allow him to withdraw his committee's registration. Mr.

Pope stated that approval of Mr. Wharton's request would eliminate the need for the committee to file a 2017 year-end report.

#### 3. Request to withdraw candidate committee registration. – Balaski (Donavon) for House

Ms. Pope told members that Mr. Balaski had registered a committee for a house seat on August 10, 2017. In response to requests for a 2017 year-end report, Mr. Balaski had told staff that he no longer was running for office and that he had raised and spent only \$50 during his campaign. Ms. Pope said that Mr. Balaski was asking the Board to allow him to withdraw his committee's registration. Ms. Pope stated that approval of Mr. Balaski's request would eliminate the need for the committee to file a 2017-year-end report.

### 4. Request for administrative termination of candidate committee – Sharon Anderson

Ms. Pope told members that Sharon Anderson had registered a committee for attorney general on January 1, 1982. Ms. Pope said that at the Board's direction, staff has not attempted to secure a report from the committee for approximately ten years. Ms. Pope stated that Ms. Anderson recently had told staff that although she plans to run again for attorney general, she has never received any contributions from anyone other than herself and has never spent more than the \$300 filing fee for the office. Ms. Anderson also told staff that she believes that she does not have a committee. Ms. Pope said that because Ms. Anderson's committee had never met the financial threshold necessary for registration of a committee and because Ms. Anderson does not believe that she has a committee, staff was asking the Board to administratively terminate Ms. Anderson's committee registration.

After discussion, the following motion was made:

Member Rosen's motion: To grant all requests on the discussion items agenda.

Re: Executive Director's Report – Board Operations

#### **Program Updates**

#### **Lobbying Program.**

The legislative session is always a busy time for lobbyist registrations. To date the Board has received 341 new registrations in 2018.

The annual lobbyist principal report of expenditures made in 2017 was due on March 15, 2018. As of March 27, 2018, reports had been received from 1,422 of the 1,427 principals required to file. An updated chart of reported expenditures and a chart showing trend lines for lobbyist expenditures are found below. There is always media interest in the principal reports, including coverage from the Star Tribune <a href="http://www.startribune.com/groups-spend-74m-to-lobby-policymakers-and-the-public-utilities-commission/477455423/">https://www.mprnews.org/story/2018/03/20/enbridge-spends-over-5-million-lobbying</a>

The reports filed so far disclose that **\$64,753,765** was spent in 2017 to influence the official actions of the legislature, administrative agencies, and metropolitan governmental units.

The amount spent to influence administrative action by the Minnesota Public Utilities Commission in cases of rate setting, power plant and power line siting, and granting of certificates of need is reported separately. In 2017, principals reported spending \$9,840,778 to influence administrative actions of the Minnesota Public Utilities Commission. This amount is the highest amount ever reported to the Board for lobbying the Minnesota Public Utilities Commission.

Total lobbying expenditures reported for 2017 amount to **\$74,594,544**. This amount is the second only to 2013 for the highest reported amount. Below is a table showing the total spending reported on the Annual Principal Reports for the last six years. A principal is permitted to round the amount reported to the nearest \$20,000.

From 2012 to 2017 the amount spend on legislative, administrative, and metro lobbying increased by 8.4%, but spending in that category has been almost static over the last four years. Spending on lobbying the Public Utilities Commission has increased by over 250% from 2012 to 2017. However, lobbying expenditures on the Public Utilities Commission can fluctuate significantly in response to a single energy project. For example, in 2017, Enbridge Energy Partners LP alone spent \$5,080,000 seeking authorization of the Line 3 project.



#### Campaign Finance Program.

The Board has registered 63 candidate committees and 9 new political committees and political funds so far this year. The first report of receipts and expenditures for constitutional candidates, appellate court candidates, political committees and funds, political party state central committees and legislative caucuses is due April 16, 2018. Approximately 450 reports are expected. House candidates, district court judges, and all other party units file their first report on July 30, 2018.

### **Economic Interest Program.**

The Board has received notification of 107 new appointments of public officials. Staff works with all new appointments to secure economic interest statements.

#### Personnel

An open house celebrating the careers of Gary Goldsmith and Joyce Larson will be held in the Board's office on Thursday, April 26, 2018, from 1:00 to 3:30 p.m.

**Re:** Legislative Update

The Board's policy recommendations and the codification of the draft administrative rules are found in SF 3306 (Kiffmeyer, Carlson) and HF 3837 (O'Driscoll, Nelson). In the Senate, SF 3306 was heard in the Committee on State Government Finance and Policy and Elections on March 15<sup>th</sup>, were it passed unanimously and then sent to the Judiciary and Public Safety Policy Committee. The bill was heard in Judiciary on March 21<sup>st</sup>, and passed without opposition, the bill has now had its second reading.

HF 3837 was heard in Government Operations and Election Policy on March 22<sup>nd</sup>. The bill passed on a voice vote, I believe the vote was 17 to 1. The bill has been sent to the Committee on Civil Law and Data Practices Policy, where it will be heard on March 29<sup>th</sup>.

As anticipated there are differences between the recommendations suggested by the Board and the provisions of the bill. The following are the significant differences by subject area.

#### **Board Investigations**

As discussed at the March Board meeting both the Senate and House bills include language that specifies the investigative authority of the Board, in particular when the investigation of a complaint discovers evidence of a potential violation not included in the complaint. The amended language specifies that the Board has authority to expand the scope of an investigation to include potential violations not alleged in the complaint. Before the scope of an investigation may be expanded the Board must hold a probable cause hearing on the new allegation, and the party under investigation has the right to appear at the determination. The proposed amendment to Minnesota Statutes, section 10A.022, subdivision 3, is underlined.

**Subd. 3. Investigation authority; complaint process.** (a) The board may investigate any alleged <u>or potential</u> violation of this chapter. The board may also investigate an alleged or <u>potential</u> violation of section 211B.04, 211B.12, or 211B.15 by or related to a candidate, treasurer, principal campaign committee, political committee, political fund, or party unit, as those terms are defined in this chapter. <u>The board may only investigate an alleged violation</u> if the board:

- (1) receives a written complaint alleging a violation;
- (2) discovers a potential violation as a result of an audit conducted by the board; or
- (3) discovers a potential violation as a result of a staff review.
- (b) When the board investigates the allegations made in a written complaint and the investigation reveals other potential violations that were not included in the complaint, the

board may investigate the potential violations not alleged in the complaint only after making a determination under paragraph (d) that probable cause exists to believe a violation that warrants a formal investigation has occurred.

(d) If a determination is made that the complaint alleges a prima facie violation, the board shall, within 45 days of the prima facie determination, make findings and conclusions as to whether probable cause exists to believe the alleged violation that warrants a formal investigation has occurred. Any party filing a complaint and any party against whom a complaint is filed must be given an opportunity to be heard by the board prior to the board's determination as to whether probable cause exists to believe a violation that warrants a formal investigation has occurred.

#### **Economic Interest Program**

The Board's policy recommendations on expanding economic interest disclosure to include the occupation and investments of the public official's spouse was not included in the legislation. The recommendation to establish a lower level of disclosure for soil and water district supervisors and water management organization members was also not included in the bill. The recommendation to raise the threshold for disclosure of investments and associated business from \$2,500 to \$10,000, and increase the income from businesses threshold from \$50 a month to \$250 a month were included. As were the draft administrative rule provisions.

#### **Notice to Contributors**

The suggested statutory language that will require a political committee, political fund, political party unit, or principal campaign committee that raises funds through the sale of goods or services to disclose to potential customers that the proceeds from the purchase are a political contribution was included.

#### Codification of the proposed administrative rules

The provisions of the draft rules are in the bills with the following exceptions:

- The two year period during which a candidate may not fundraise for a political committee
  that subsequently makes an independent expenditure provided in the rules is reduced to
  a one year period.
- A provision that specified that any expenditure made by a political committee in which
  the spouse or domestic partner of the candidate serves as an officer is a coordinated
  expenditure was not included.
- A provision was added that, taken by itself, the fact that a candidate's committee
  provided a party unit or political committee with its donor list is not an act of coordination
  that defeats the independence of expenditures. This provision was amended in the HF
  3837 to clarify that a political committee could not inform the candidate that the list would
  be used for independent expenditures.

These changes have created opposition. Attached is a letter from the League of Women Voters to the Senate stating that the organization is in favor of the bill, but would prefer amendments on these three issues. My understanding is that Common Cause has similar concerns.

#### **Include Definition of Election Segment**

 "Election segment" is added to the subdivision defining "Agent," and the section on "Consulting Services."

However, "election segment" is not definition in the bill or current law. We would like the
definition that the Board drafted to be included in the statute as well.

#### Include "Election Segment" for All Subdivisions Rather Than Calendar Year

- This bill is different from the draft Board rules in that it limits some coordinated expenditures definitions to "on or after January 1 of the year the office will appear on the ballot."
- This is different from the rules that the Board drafted that included the entire election segment, a 2 year period. Thus, this change shortens the applicable period by 14 months to just 10 months.
- Could be abused by candidates with early and long campaigns.

#### Include Expenditures Directed by Spouse or Domestic Partner

- The Board's draft rules included an expenditure made during the election cycle by a spender established, directed, or managed during the same election cycle by the candidate's spouse or domestic partner.
- The rationale behind that rule was that it was unreasonable to believe that a candidate and their spouse would not discuss nonpublic details of the campaign, which would otherwise be a coordinated expenditure.

#### **Include Lists of Potential Donors from Candidates to Spenders**

- The Board's draft rules also did not include one noncoordinated expenditure that was added during the drafting of this bill.
- Page 20, line 1 of the bill adds a new category of noncoordinated expenditure for when a candidate provides to a spender names of potential donors.
- This is still coordinating spending. A candidate's committee would be able to compile a list of individuals and PACs that have donated to the candidate.

**Re:** Prima facie determination finding no violation

Complaints filed with the Board are subject to a prima facie determination made by the Board chair in consultation with staff. If the Board chair determines that the complaint states a violation of Chapter 10A or the provisions of Chapter 211B under the Board's jurisdiction, the complaint moves forward to a probable cause determination by the full Board.

If, however, the chair determines that the complaint does not state a prima facie violation, the Chair must dismiss the complaint without prejudice. When a complaint is dismissed, the complaint and the prima facie determination become public data. The following complaint was dismissed by the chair and the prima facie determination is provided here as an informational item to the other board members. No further action of the Board is required.

#### **Complaint regarding Michael Northbird**

On March 8, 2018, the Campaign Finance and Public Disclosure Board received a complaint submitted by Soren Sorensen regarding Michael Northbird, the candidate. The complaint alleged that the candidate had sent a mailing to the delegates of the DFL's SD2 endorsing convention seeking support at the endorsing convention without the required disclaimer language. While the mailing did not include the required disclaimer language, at the time the mailing had been sent the candidate was not a registered candidate with the Board. Minnesota Statutes section 211B.04 does not apply "to an individual or association that is not required to register or report under Chapter 10A." Minnesota Statutes section 10A.14 requires "[t]he treasurer of a . . . principal campaign . . . to register with the board by filing a registration statement." Registration with the Board is required "no later than 14 days after the committee . . . has made a contribution, received contributions, or made expenditures in excess of \$750." It was unlikely that the mailing exceeded \$750, and therefore, the Board Chair made a determination on March 14, 2018, that the complaint did not state a prima facie violation.

IN THE MATTER OF THE COMPLAINT OF SOREN SORENSEN REGARDING MICHAEL NORTHBIRD:

On March 8, 2018, the Campaign Finance and Public Disclosure Board received a complaint submitted by Soren Sorensen regarding Michael Northbird.

The complaint states that Mr. Sorensen, a delegate to the DFL's SD2 endorsing convention, received a campaign mailing sent by candidate, Michael Northbird, seeking support at the DFL's SD2 endorsing convention for District 2A. The complaint alleges that Mr. Northbird's mailing did not have the required disclaimer language.

#### **Determination:**

Minnesota Statutes section 211B.04 requires candidates to include a disclaimer on all campaign materials that states "Prepared and paid for by the ... committee, ... (address)." The materials mailed by Mr. Northbird are campaign materials under the meaning of section 211B.04, as they were seeking the "endorsement and support for State Representative 2A." However, section 211B.04 also provides that "[the] section does not apply to an individual or association that is not required to register or report under chapter 10A."

In this matter, the candidate who is the subject of the complaint has not registered or reported to the Board. Minnesota Statutes section 10A.14 requires "[t]he treasurer of a . . . principal campaign . . . to register with the board by filing a registration statement." Registration with the Board is required "no later than 14 days after the committee . . . has made a contribution, received contributions, or made expenditures in excess of \$750."

The complaint provided a copy of the campaign materials and it appears that Mr. Northbird has made some expenditures in sending this mailing to approximately 100 delegates to the endorsing convention. However, it is not likely that Mr. Northbird made expenditures in an amount over \$750 in this mailing. Thus, there is no basis to conclude that the disclaimer requirements of Minnesota Statutes section 211B.04 apply to the campaign material provided with the complaint. The allegations in the complaint therefore do not support a finding of a prima facie violation regarding the disclaimer requirements.

Pursuant to Minnesota Statutes section 10A.022, subdivision 3, paragraph (1), this prima facie determination is made by a single Board member and not by any vote of the entire Board. Based on the above analysis, the Chair concludes that the complaint does not state a prima facie violation of Chapter 10A or of those sections of Chapter 211B under the Board's jurisdiction. The complaint is dismissed without prejudice.

#### A. Discussion items

#### 1. Request to amend lobbyist termination statement – Dustin Brighton

In January 2018, Mr. Brighton terminated his registration as a lobbyist for the Internet Association because he left his position with that organization. Because Mr. Brighton used the January 2018 date as his termination date, he must file a lobbyist disbursement report by June 15, 2018, for the short time that he worked during this year. The Internet Association is asking the Board to amend Mr. Brighton's termination statement to be effective on December 31, 2017. Approval of this request would eliminate the need for Mr. Brighton to file the June 2018 lobbyist disbursement report. The Internet Association states that Mr. Brighton did not conduct any lobbying in 2018 and had no lobbying disbursements.

## 2. Request to suspend efforts to obtain economic interest statement and accrual of late fees and civil penalties – Rolf Hagen

Mr. Hagen is a public official with the Office of Administrative Hearings. Due to health issues, Mr. Hagen is not able to file his annual statement of economic interest statement himself or direct someone else to complete it for him. Mr. Hagen's family is in the process of obtaining the authority necessary to act for him. After that authority is obtained, Mr. Hagen's representative will file the statement and submit a waiver request for the accrued late fees. Mr. Hagen's family is asking the Board to suspend its efforts to obtain the statement and the accrual of the late fees until that time.

## 3. Confirmation of lobbyist termination and cessation of efforts to collect lobbyist report – Jim du Bois

Mr. du Bois was the executive director of the Minnesota Broadcaster's Association and also was registered as a lobbyist for the Association. The Association notified Board staff that Mr. du Bois had resigned as executive director in December 2017 after the discovery of irregularities in the Association's management. Staff then administratively terminated the lobbyist registration of Mr. du Bois. Staff is asking the Board to confirm this termination.

In addition, Mr. du Bois has not filed the lobbyist disbursement report that was due on January 15, 2018. The Association has examined its records and concluded that Mr. du Bois did not make any lobbyist disbursements during the time covered by the missing report. The Association's other two lobbyists have filed their reports and the Association has filed its 2017 principal report. Staff therefore is asking the Board to confirm the cessation of staff efforts to obtain the January 2018 lobbyist report from Mr. du Bois.

This letter is intended to supplement the request of the Minnesota Broadcaster's Association (the "Association") to terminate the Lobbyist Registration of Mr. Jim du Bois that was requested on March 20, 2018. It is also intended to provide a response to the letter received from Ms. Waller dated March 21, 2018.

Until yesterday, the Association was not aware of the Campaign Finance and Public Disclosure Board's ("Board") concern regarding the Association's 2016 Lobbyist Principal Report. Upon receipt of Ms. Waller's letter, the Association immediately took steps to amend its 2016 report to address the concerns raised by the Board. It is our understanding that the amended report now clears up any questions related to lobbyist activities conducted by the Association in 2016.

As you know, since Mr. du Bois' resignation in December 2017, the Association has been working hard to address organizational and operational issues including significant outstanding debt, unpaid bills and financial deficiencies. Accordingly, we respectfully request that the Board waive the late filing fee. In support of this request, we ask the Board to consider the fact that (a) the Association took immediate action upon learning of the problem; and (b) the Association faces extreme financial hardship and is working to determine if it will be able remain viable.

Finally, in working with the certified public accountant who has been hired to reconstruct the Association's financial records, and also in speaking with the contract lobbyists who previously represented the Association in advocacy matters, it is our understanding and belief that Mr. du Bois had no lobbyist disbursements to report in his missing lobbyist disbursement report. Based on this, we ask the Board to grant our request for the administrative termination of Mr. du Bois' lobbyist registration.

My hope is that my situation at the time before the reports were due on 1-16-2018 may change your decision.

I am born and raised in Lac qui Parle county, just south of Appleton MN. 150 miles west of Minneapolis. My family farm is still active. This past year my father's Alzheimer's became progressive enough that we had to put him in a memory care unit during May 2017. My mother continued to live at the farm.
