#### **MINUTES**

**MINUTES** (July 28, 2021)

After discussion, the following motion was made:

Member Flynn's motion: To approve the July 28, 2021, minutes as drafted.

Vote on motion: A roll call vote was taken. All members voted in the

affirmative.

#### **CHAIR'S REPORT**

#### A. 2021 meeting schedule

The next Board meeting is scheduled for 10:00 a.m. on Wednesday, October 6, 2021.

#### **EXECUTIVE DIRECTOR REPORT**

Mr. Sigurdson presented members with a memorandum regarding this matter that is attached to and made a part of these minutes. Mr. Sigurdson told members that all state agencies are required to annually certify that they have reviewed their internal control systems and procedures, and are either in compliance with the standards and policies established by Minnesota Management and Budget (MMB), or are taking the actions described to gain compliance with those standards. Mr. Sigurdson said that the self-assessment tool and certification cover 65 state policies ranging from code of conduct training for staff to the procedures used to prevent fraud and safeguard public funds. Mr. Sigurdson stated that this was the first year that the Board could certify that it had policies or controls in place that complied with all applicable standards.

Mr. Sigurdson next told members that staff had scheduled Webex compliance training sessions in September and October and that many people had already registered for those classes. Mr. Sigurdson also said that the Centennial Office Building remained closed to the public. Mr. Sigurdson stated that staff was rotating so that only two or three people were physically present in the office each day.

#### A. Review of legislative recommendations regarding lobbying

Mr. Sigurdson next reviewed the chronology of events for the lobbyist legislative recommendations that had been prepared at the request of Chair Swanson. Mr. Sigurdson noted that work on the legislation began in October of 2019 and continued until the House bill was laid on the table in March of 2021. Mr. Sigurdson said that he soon would reach out to the Minnesota Governmental Relations Council (MGRC) to begin discussions about the legislation in preparation for the 2022 session.

#### B. Request for Board guidance – contributions to charities

Mr. Sigurdson presented members with a memorandum regarding this matter that is attached to and made a part of these minutes. Mr. Sigurdson told members that Anton Lazzaro was a prolific political contributor who recently had been charged with several crimes. Mr. Sigurdson said that many candidate committees and party units that had received contributions from Mr. Lazzaro had announced that instead of returning those contributions to Mr. Lazzaro, they would be donating an equivalent amount to charity. Mr. Sigurdson said that the entities were not required to return these funds or to donate them. Mr. Sigurdson also stated that campaign finance laws allow committees and party units to donate to 501(c)(3) charities but that there is a \$100 per charity, per calendar year limit on these donations. Mr. Sigurdson said that although staff had alerted all committees and party units that had received contributions from Mr. Lazzaro in the past about the \$100 limit, staff expected to see violations of the charitable contribution limit on 2021 year-end reports. Mr. Sigurdson stated that the usual remedy for these violations was for the committee or party unit get the money back from the charity. If the donor was a candidate committee, the candidate also could use personal funds to reimburse the committee for the amount of the donation that was over \$100. Mr. Sigurdson said that he wanted members to be aware of this potential issue and asked for guidance on how to respond. Members discussed the matter and recommended additional outreach in the coming months to make candidates and party units aware of the limit in time to cure any violations. Members may revisit the issue after the 2021 year-end reports have been filed and the scope of the problem is known.

#### C. 2020 Lobbyist Disbursement Summary

Mr. Sigurdson presented members with a copy of the 2020 Lobbyist Disbursement Summary that is attached to and made a part of these minutes. Mr. Sigurdson told members that the summary was one of four reports required by statute and that the other three reports would be presented to members at upcoming meetings. Mr. Sigurdson said that the summary was provided for informational purposes only and that no Board action was necessary.

#### **ENFORCEMENT REPORT**

#### A. Discussion items

1. Marcus Harcus (House candidate) and lobbyist (2632) and MN Campaign for Full Legalization (7379) – Late fees and civil penalties for multiple reports and candidate EIS

Mr. Olson told members that Mr. Harcus owed a late filing fee of \$100 and a civil penalty of \$1,000 for his candidate statement of economic interest, which was due June 16, 2020 and filed May 20, 2021. Mr. Olson said that Mr. Harcus was the sole lobbyist, and the executive director, of MN Campaign for Full Legalization. Mr. Olson said that Mr. Harcus owed a total of \$6,200 in late filing fees and civil penalties for the lobbyist disbursement reports listed below:

- Report due January 18, 2021 and filed May 20, 2021 \$1,000 LFF
- Report due June 15, 2020 and filed May 20, 2021 \$1,000 LFF and \$1,000 CP
- Report due January 15, 2020 and filed May 20, 2021 \$1,000 LFF and \$1,000 CP
- Report due January 15, 2019 and filed March 16, 2019 \$1,000 LFF
- Report due June 15, 2018 and filed June 27, 2018 \$200 LFF

Mr. Olson said that MN Campaign for Full Legalization owed a total of \$4,275 in late filing fees and civil penalties for the lobbyist principal reports listed below:

- Report due March 15, 2021 and filed May 20, 2021 \$1,000 LFF and \$1,000 CP
- Report due March 16, 2020 and filed May 20, 2021 \$1,000 LFF and \$1,000 CP
- Report due March 15, 2019 and filed April 1, 2019 \$275 LFF

Mr. Olson stated that in June 2019 the Board had reduced the total amount owed at that time for late filing fees for lobbyist disbursement reports from \$1,200 to \$200, and the LFF for the lobbyist principal report due in March 2019 from \$275 to \$200, contingent upon payment of the remaining balance. No payment was received despite two letters sent to Mr. Harcus seeking payment. Mr. Olson said that the amounts owed therefore reverted back to the original amounts. The Board referred the matter to the Attorney General's Office in September 2020.

Mr. Olson told members that Mr. Harcus had terminated his lobbyist registration effective May 20, 2021, and had timely filed both the lobbyist disbursement report due June 15, 2021, and the lobbyist principal report covering 2021 that will be due on March 15, 2022. Mr. Olson also said that Mr. Harcus no longer had an active principal campaign committee registered with the Board and had no outstanding or upcoming reports. Mr. Olson stated that Mr. Harcus was asking that the total amount owed of \$11,575 be reduced to \$1,000, which was the balance remaining in the bank account of MN Campaign for Full Legalization. Mr. Olson said that Mr. Harcus had explained that his failure to timely file multiple reports was caused by personal problems and health issues that had hampered his ability to deal with the outstanding issues over the past several years. Mr. Olson told members that there was no staff recommendation in this matter because there were no comparable past cases for comparison.

Marcus Harcus then addressed the Board. Mr. Harcus described the personal and medical issues that had prevented him from timely filing his reports. Mr. Harcus said that he planned to dissolve MN Campaign for Full Legalization and that his only lobbying in the future would be as a citizen lobbyist. Mr. Harcus also clarified that there actually was only about \$15 in the account of MN Campaign for Full Legalization. Mr. Harcus thanked staff for helping him and the Board for considering his request.

After discussion, the following motion was made:

Member Soule's motion:

To reduce the late filing fees for the lobbyist disbursement reports to \$2,500; to waive all other late filing fees and civil penalties owed; to require \$1,000 of the \$2,500 owed to be paid according to a payment plan developed by the executive director; to stay payment of the remaining \$1,500 for two years and then waive this amount if Mr. Harcus has had no other late reports; and to put the litigation on hold during this time.

Vote on motion:

A roll call vote was taken. All members voted in the affirmative.

## 2. Jenny Rhoades for Governor (18141) and Jenny Rhoades (Senate candidate) – Late fees for two reports of receipts and expenditures and late fee and civil penalty for candidate EIS

Mr. Olson told members that Ms. Rhoades owed late filing fees of \$25 for the 2017 year-end report of receipts and expenditures and \$525 for the 2018 year-end/termination report of Jenny Rhoades for Governor (18141). Mr. Olson stated that the Rhoades committee had registered in April 2017 and had disclosed less than \$500 in total receipts and less than \$500 in total disbursements during the course of its existence. Mr. Olson said that Ms. Rhoades had explained that she attempted to file a termination report covering 2018 via the CFR software prior to the 2018 year-end report coming due on January 31, 2019. Mr. Olson stated that a 2018 1st quarter report was timely filed via the software in April 2018, but that Board staff had no record of any subsequent attempts to upload a report prior to the due date of the 2018 year-end report. Mr. Olson said that a report covering 2018, labeled as a termination report, was filed on March 4, 2019, via the CFR software and that the late filing fee of \$525 was based on that date. Mr. Olson stated that the termination report was later amended to list a cash balance of less than \$100, allowing the committee to be terminated. Mr. Olson said that Board staff recommended that the late filing fees totaling \$550 for the 2017 year-end and 2018 year-end/termination reports be waived because the committee did not receive contributions or make expenditures in excess of \$750, and therefore was not required to register with the Board.

Mr. Olson also said that Ms. Rhoades was a candidate for state senator in 2020 and owed a late filing fee of \$100 and a civil penalty of \$1,000 for her candidate statement of economic interest, which was due June 15, 2020, and filed July 8, 2021. Mr. Olson said that Ms. Rhoades had stated that she was

not aware of her failure to file her candidate EIS until she was served with a summons and complaint on June 29, 2021. Mr. Olson said that on July 7, July 30, and August 21, 2020, letters were sent to the address listed on the affidavit of candidacy that Ms. Rhoades had filed, explaining that her EIS had not been received. A copy of the letter dated August 21, 2020, also was sent to the email address that Ms. Rhoades listed on her affidavit of candidacy and her principal campaign committee's statement of organization, which was the same email address that Ms. Rhoades had used on several occasions to communicate with Board staff.

Mr. Olson told members that Ms. Rhoades also had said that she uploaded the wrong attachment in July 2020. Mr. Olson said that it was unclear which attachment she was referring to, but that Ms. Rhoades had emailed a copy of a paper 2020 pre-primary report for the Jenny Rhoades for SD49 committee (18681) to Board staff on July 27, 2020. Mr. Olson said that the body of that email did not contain any text and the subject line was "Report 18681," appearing to indicate that the intent of the email was to file a pre-primary report, rather than an EIS. Regardless, Board staff mailed two letters and emailed Ms. Rhoades after that date, informing her that an EIS had not been received.

Mr. Olson said that Ms. Rhoades had no prior waiver requests pertaining to her terminated principal campaign committees or to an EIS. Mr. Olson stated that Ms. Rhoades had explained the various personal problems that she encountered in 2020 within her waiver request. Mr. Olson said that Board staff recommended that the civil penalty be reduced from \$1,000 to \$500, which combined with the \$100 late filing fee would leave a balance owed of \$600 for the candidate EIS.

Jenny Rhoades then addressed the Board. Ms. Rhoades described the software issues that she encountered in 2018 when she was trying to file her campaign finance reports. Ms. Rhoades also described the medical and personal issues that prevented her from timely filing her candidate statement of economic interest.

After discussion, the following motion was made:

Member Rosen's motion: To adopt the staff recommendation by waiving the late

filing fees totaling \$550 incurred by the Jenny Rhoades for Governor committee and reducing the civil penalty for the

candidate EIS from \$1,000 to \$500.

Vote on motion. A roll call vote was taken. All members voted in the

affirmative.

#### **B.** Waiver requests

#### 1. MMGMA PAC (80017) - September 2020, 2020 pre-general, 2020 year-end - \$3,000 LFFs

Data was entered in the CFR software and the fund attempted to upload each report on its due date. The Board's computer logs show that each upload was attempted and failed and that upload of the year-end report was attempted twice. The uploads may have failed for a variety of reasons including

loss of internet connection during the upload process or a firewall issue. Political funds are not required to file a report if they have had no financial activity since the period covered by a previous report, so Board staff did not contact the fund immediately after the reports were due. The issue was discovered as part of the reconciliation process and the missing reports were filed 6/30/2021 after the fund realized they had not been received. The fund reported a cash balance of \$464 as of the end of 2020. RECOMMENDED ACTION: Waive

Courtney Jasper, a lobbyist for the MMGMA, addressed the Board to thank staff for the assistance provided with filing the reports and the waiver request.

After discussion, the following motion was made:

To waive the late filing fees.

#### 3. YWCA of Minneapolis (5052) - 2020 lobbyist principal - \$250 LFF

Responsibility for filing the report due 3/15/2021 was transferred to a new employee and the principal believed that a report did not need to be filed if there were no lobbying expenditures. The report was filed 3/29/2021. In May 2020, a \$1,000 CP was waived and a \$1,000 LFF for the 2018 report was reduced to \$500 because the designated lobbyist experienced personal issues that delayed the filing of the report. RECOMMENDED ACTION: Reduce to \$125

Luna Allen-Bakerian, Race, Equity, and Public Policy Strategist for the YWCA of Minneapolis, addressed the Board. Ms. Allen-Bakerian told members that the report was not timely filed due to staff turnover and the fact that working from home prevented staff from seeing the mailed notice until after the due date. Ms. Allen-Bakerian thanked staff for the help filing the report.

After discussion, the following motion was made:

Member Leppik's motion: To reduce the late filing fee to \$125.

Vote on motion: A roll call vote was taken. All members voted in the

affirmative.

#### **REVIEW OF RECENT JUDICIAL OPINIONS**

#### A. Americans for Prosperity Foundation v. Bonta

Mr. Olson presented members with a memorandum regarding this matter that is attached to and made a part of these minutes. Mr. Olson told members that this case arose out of a California law requiring charitable organizations that solicit contributions in that state to register with the state attorney general and to file annually a copy of the Form 990 that they filed with the IRS, including Schedule B. Schedule B generally consists of a list with the name and address of, and amount contributed by, each person who contributed at least \$5,000 to the organization. Mr. Olson said that several 501(c)(3) organizations challenged the Schedule B disclosure requirement. In July 2021, the United State Supreme Court issued a 6-3 decision striking down California's Schedule B requirement on its face, with the majority concluding that the requirement burdened donors' First Amendment rights and was not narrowly tailored to an important government interest.

Mr. Olson stated that the justices had split with respect to what level of scrutiny generally applies to disclosure requirements and briefly reviewed the positions taken by the justices. Mr. Olson said that the six justices in the majority each joined the portion of the Court's opinion holding that "[w]hile exacting scrutiny does not require that disclosure regimes be the least restrictive means of achieving their ends, it does require that they be narrowly tailored to the government's asserted interest." The majority went on to state that a substantial relationship between the governmental interest and the means employed "is necessary but not sufficient to ensure that the government adequately considers the potential for First Amendment harms before requiring that organizations reveal sensitive information about their members and supporters. Where exacting scrutiny applies, the challenged requirement must be narrowly tailored to the interest it promotes, even if it is not the least restrictive means of achieving that end." Mr. Olson said that the majority also held that a facial challenge to a disclosure

requirement need not include evidence "that donors to a substantial number of organizations will be subjected to harassment and reprisals," if the disclosure requirement is not narrowly tailored.

Mr. Olson stated that applying exacting scrutiny, the majority noted that while "California has an important interest in preventing wrongdoing by charitable organizations," "[t]here is a dramatic mismatch" between that interest and the Schedule B disclosure requirement, because California did not cite "a single, concrete instance in which pre-investigation collection of a Schedule B did anything to advance the Attorney General's investigative, regulatory or enforcement efforts." Mr. Olson said that the majority went on to note that disclosure requirements can chill freedom of association even when there is no disclosure to the general public, and ultimately concluded that California's Schedule B disclosure requirement was not narrowly tailored and was invalid on its face.

Mr. Olson then reviewed the potential impact of the case on Chapter 10A. Mr. Olson noted that Chapter 10A differs from California's Schedule B disclosure requirement in at least two ways. First, the purpose of disclosure under Chapter 10A is to ensure that the disclosed information is available to the general public, which, in the campaign finance context, the United States Supreme Court has long held is "the least restrictive means of curbing the evils of campaign ignorance and corruption . . ." Mr. Olson said that the second difference is that the information disclosed pursuant to Chapter 10A is routinely used by the Board to enforce Chapter 10A and by journalists and the general public for many purposes, including bringing possible violations of Chapter 10A to the attention of the Board. Mr. Olson stated that these distinctions decreased the likelihood that the Court's decision would have a direct impact on Chapter 10A. Mr. Olson told members, however, that the Court's clear articulation of a tailoring requirement applicable to disclosure requirements subject to exacting scrutiny might make it easier to challenge the constitutionality of disclosure requirements if those requirements were likely to chill speech or association.

#### B. Thompson v. Hebdon

Mr. Olson presented members with a memorandum regarding this matter that is attached to and made a part of these minutes. Mr. Olson told members that this case arose out of an Alaska law that prohibited individuals from giving contributions in excess of \$500 per calendar year to any particular state candidate or to any political group aside from political parties and independent expenditure and ballot question groups. Mr. Olson said that the law was challenged by individuals who wanted to give contributions over the limit and who argued, in part, that the limit was so low that it violated the First Amendment. Mr. Olson stated that a federal district court upheld the \$500 limit as did the Ninth Circuit Court of Appeals. However, in November 2019, the United States Supreme Court ordered the Ninth Circuit to reconsider its decision in light of *Randall v. Sorrell.* Mr. Olson said that in *Randall*, six Supreme Court justices agreed that Vermont's contribution limits violated the First Amendment and five of them joined opinions that explicitly stated that part of the reason the contribution limits were constitutionally infirm was because the dollar amounts were simply too low.

Mr. Olson told members that on remand a divided three-judge Ninth Circuit Court of Appeals panel struck down Alaska's \$500 individual contribution limit. Mr. Olson said that the majority concluded that the annual limit restricted the amount of funds available to challengers because they typically do not

enter political races until the year of the general election and therefore could not raise money in the off-year. Mr. Olson stated that the majority also concluded that the already-low limit was not indexed for inflation and was the same as it had been in 1996, and that Alaska had not established a special justification for such a low limit. Mr. Olson said that the Ninth Circuit now was deciding whether to reconsider the case *en banc*.

Mr. Olson said that although there was no immediate impact on the validity of Chapter 10A's contribution limits, some aspects of the majority's opinion were notable in light of similarities and dissimilarities between Alaska's individual contribution limit and Chapter 10A. Mr. Olson stated that the court noted that Alaska's individual contribution limit was not indexed to inflation, which was one of the factors set forth in *Randall*. Mr. Olson noted that while Chapter 10A's aggregate special source contribution limits are indexed to inflation, the individual contribution limits and party unit and dissolving principal campaign committee aggregate contribution limits are static. Mr. Olson said, however, that those limits had been increased considerably in 2013.

Mr. Olson next told members that Chapter 10A's individual contribution limit applies to two-year election cycle segments rather than single calendar years. Mr. Olson said that the issue of challengers potentially having only an election year to accept contributions therefore did not result in an effectively lower individual contribution limit. Mr. Olson finally noted that Alaska's \$500 individual contribution limit applied to all state candidates, including candidates for governor and lieutenant governor, whereas Chapter 10A establishes varying contribution limits depending on the office sought that are significantly higher than the Alaska limit.

#### **LEGAL COUNSEL'S REPORT**

Mr. Hartshorn presented members with a legal report that is attached to and made a part of these minutes. Mr. Hartshorn told members that the Gunderson matter had been resolved and that the Harcus and Rhoades matters would be placed on hold to allow them to pay their fees in accordance with the waivers just granted. Mr. Hartshorn said that the Partlow matter also was on hold due to a request for reconsideration. Mr. Hartshorn stated that work was moving forward on the summary and default judgment motions in the other cases.

#### **OTHER BUSINESS**

There was no other business to report.

**Re:** Executive Director's Report

<u>Campaign Finance Training</u>: Staff conducted a Webex campaign finance compliance training class on September 14, 2020. About 40 candidates and treasurers attended the training. The next Webex training is scheduled for the evening of October 7<sup>th</sup> at 6:00 PM; as of the date of this memo 53 individuals have signed up for the class. <u>Political Contribution Refunds in 2020</u>: The political contribution refund (PCR) program is administered by the Department of Revenue (DOR) as provided in Minnesota Statutes section 290.06. The program provides that an eligible Minnesota voter who makes a cash contribution to a candidate who has signed the public subsidy agreement, or to a major or minor political party unit, may apply for a refund from the DOR. The maximum amount that may be refunded in a calendar year is \$50 per person, or \$100 per married couple. The DOR tracks refunds so that no individual receives more than a \$50 refund in a calendar year.

The Campaign Finance Board provides a computer file to the DOR that lists all candidate committees that have a current public subsidy agreement on file and all political party units registered with the Board. The DOR uses that information to verify that the donor gave to a candidate or party unit eligible to issue a PCR receipt. The Board also provides paper PCR receipts to eligible candidates and party units and has developed the Campaign Finance Reporter software so that the software can be used to generate a PCR receipt.

In August of each year the DOR reports to the Board the number of PCR refunds, and the total value of the refunds, issued to donors in the prior calendar year. The report provides the refund totals for individual candidate committees and political party units. On the website there are separate reports for candidates and party units for the years 2013 through 2020.


The Board compares the PCR refunds issued for contributions to candidates and political party units to the contributions disclosed on the reports of receipts and expenditures filed with the Board. The comparison is used to verify that the value of the refunds issued to contributors to a

candidate or party unit do not exceed the contributions reported as received by that same candidate or party unit.

In 2020 the DOR issued 35,293 refunds with a total value of \$3,517,084. Of that amount \$1,326,904 was issued for contributions made to candidates, and \$2,190,180 was issued for contributions to political parties.


In 2020, individuals contributed about \$1,700,000 more in total contributions to DFL candidates than RPM candidates. Nonetheless, in total, individuals who contributed to RPM candidates were refunded more by the DOR than contributors to DFL candidates. The DOR refunded about 20% of all funds contributed to RPM candidates by individuals, compared to about 13% for individuals who contributed to DFL candidates, as seen in Figure 1.

Historically, RPM party units have issued more PCR receipts than DFL party units, but for the first time since at least 2002, individuals who contributed to DFL party units received more in total refunds, \$1,162,659, than contributors to RPM party units, \$1,022,355, see Figure 2.

In 2020 contributors to minor political parties received the following total refunds: the Independence Alliance Party \$600, the Legal Marijuana Now Party \$200, the Libertarian Party of Minnesota \$1,150, the Green Party of Minnesota \$1,930, and the Grassroots Legalize Cannabis Party \$1,125.

The 2020 reports for PCR refunds issued by specific candidate committees and political party units are attached to this report.

#### 2020 Campaign Finance Summary

Attached to this report is the campaign finance summary covering the 2019 – 2020 election segment. The report is filed with the legislative reference library. So that the report is as accurate as possible it is not finished until after the reconciliation of contributions from registered committees referenced above is substantially complete.

## A. Discussion Items

## 1. Administrative termination of lobbyist Rafael Espinosa (4696)

AFSCME 65 and Carver County Local 2789 have requested that the lobbyist registration of Mr. Espinosa be terminated retroactive to February 9, 2021, as he is no longer employed by those principals. Board staff attempted to contact Mr. Espinosa to ask him to file termination statements, but he has not done so. A reporting lobbyist for the same principals filed disbursement reports inclusive of Mr. Espinosa through May 2021, so there will be no outstanding reports if the termination is retroactive to February 2021.

## 2. Balance adjustment request - Mahoney (Tim) for House (15823)

The Mahoney committee's actual cash balance at the end of 2020 was \$3,010.42, which is \$400.17 less than the ending cash balance of \$3,410.59 listed on the committee's amended 2020 year-end report. The committee believes that the discrepancy likely accumulated over the course of several years, prior to 2019, and is unsure of the cause. The committee is therefore requesting a downward balance adjustment of \$400.17 to its 2020 ending cash balance. The committee will file a termination report by mid-October.

SUBJECT: Yearly Update on Reconciliation of Contributions between Registered Committees

## **Background**

In the fall of 2013, the Star Tribune published an article describing problems found in the database of contributions to state candidates, political party units, and political committees and funds provided to the paper by the Campaign Finance and Public Disclosure Board. In particular the Star Tribune found that it could not reconcile over \$20 million dollars in contributions reported between registered committees during the years 2000 to 2012. Staff confirmed that the problems identified in the article existed, and during the remainder of 2013, all of 2014, and the first quarter of 2015, worked to reduce the number of contributions between registered entities that did not reconcile.

At the August 2015 Board meeting staff reported to the Board on the progress made in reconciling contributions, and reported on nine steps implemented by the executive director to minimize unreconciled contributions in future reporting years. The Board directed staff to stop the active reconciliation of contributions made prior to 2014, and to report annually to the Board regarding the reconciliation of contributions for the prior reporting year. This memo provides the status of the reconciliation of contributions between registered entities reported in 2020.

#### Reconciliation of 2020

The 2020 year-end reports of receipts and expenditures were due on February 1, 2021. The reports were processed using procedures designed to limit the number of unreconciled contributions caused by data entry errors. These procedures include double checking the data entry of paper reports by staff and requiring treasurers to submit complete amended reports if warranted.

In Table 1 the 2020 reconciliation numbers are highlighted in grey. The years 2010 – 2019 are provided for comparison.

The reconciliation process takes considerable staff time to complete. Staff initially reached out informally through email to treasurers with a reconciliation issue and asked them to review their records on specific contributions. A significant number of problems were resolved through emails and subsequent amendments. Formal letters requiring a response were mailed to 343 candidate committees and 281 political committees and party units in March and April of this year. In almost all cases, amendments were secured from the donor, the recipient, or both to resolve the discrepancies. Staff is still working with five committees to resolve contributions that do not reconcile.

## **ADVISORY OPINION 454**

#### SUMMARY

A political party unit may lease meeting space for use by elected members of the party and other individuals who pay a membership fee for use of the facility. The payment of a membership fee is a contribution to the party unit. The value of the facility may, in part, constitute in-kind contributions to the campaign committees of elected members.

#### **Facts**

As a representative of a registered political party unit (the party unit), you ask the Campaign Finance and Public Disclosure Board for an advisory opinion based on the following facts which were provided to the Board in a written request and through conversations with Board staff.

- 1. The party unit holds events for its members during the legislative session. Finding a location to hold these events, and for informal meetings by members, has been complicated by the pandemic and its related restrictions on the use of public space and the limited availability of private space.
- 2. The party unit intends to lease space for use by the party unit, elected members of the party, staff, and invited guests during the legislative session. The party unit will pay fair market value for use of the space.
- 3. The party unit views the cost of meeting space for its activities and its members as an expenditure for "office and other space" that supports the political purpose of re-electing its members.<sup>1</sup> The space will be used, in part, to support the development of legislation that supports the party's political agenda. Passage of legislation and development of policies that are in line with the party's goals will directly support the election of party candidates.
- 4. The leased space will not be open to the general public. In order to use the facility elected members of the party will be required to pay a membership fee that is specifically for access to the facility. The amount of the membership fee has not been

determined, but any fees collected will be used for the party unit's administrative costs. The party unit does not intend to pay for the lease of the facility through the membership fees paid by elected members of the party.

- 5. The party unit will offer limited memberships to individuals who are not elected office holders. The limited memberships will provide access to use the facility, but will not provide any other rights or duties within the party unit. Limited memberships will be offered at the discretion of the party unit. The cost of a limited membership may be greater than the membership fee for elected members of the party unit.
- 6. The party unit will not allow candidates to hold fundraisers at the facility during the legislative session.
- Food and beverages will be available for purchase at the meeting facility at fair market value. Members will be responsible for the purchase of any food or beverage items for themselves or guests.
- 8. The party unit and its elected members are aware of and comply with the prohibition on contributions from lobbyists during the legislative session. See Minn. Stat. § 10A.273.
- 9. The party unit and its elected members are aware of and comply with the gift prohibition between lobbyists and public officials. See Minn. Stat. § 10A.071.

With this background in mind, the party unit asks the following questions.

#### Issue One

Does providing elected members with a meeting space result in a contribution from the party unit to the elected members which must be reported to the Board?

## **Opinion One**

Yes. Minnesota Statutes section 10A.01, subdivision 4, defines an approved expenditure as follows:

"Approved expenditure" means an expenditure made on behalf of a candidate by an entity other than the principal campaign committee of the candidate, if the expenditure is made with the authorization or expressed or implied consent of, or in cooperation or in concert with, or at the request or suggestion of the candidate, the candidate's principal campaign committee, or the candidate's agent. An approved expenditure is a contribution to that candidate.

Minnesota Rules part 4503.0800, subpart 4, further provides, "The fair market value of shared office space or services provided to a candidate without reimbursement is a donation in kind."

As described in the facts of the request, the membership fees paid by elected members will be applied against the administrative overhead of the party unit, and will not pay for the cost of the meeting space. For elected members, the value of the use of the facility is an approved expenditure by the party unit (a type of donation in kind) on behalf of those candidates. By definition, an approved expenditure is a contribution to the elected member's campaign committee.

The approved expenditure for use of the meeting facility is a contribution from a political party unit, and will count against the aggregate political party unit limit of the elected member's campaign committee. Because the approved expenditure counts against the political party contribution limit, if the value of the approved expenditure exceeds \$20 an elected member's campaign committee must provide a written acknowledgement to the party unit of the donation and authorizing the approved expenditure at a set amount.<sup>2</sup>

In determining the value of the meeting facility to elected members the party unit should subtract from the cost paid for the leased space and any associated costs for operating the facility the value to the party unit of holding its meetings at the location. The remaining cost is a benefit that then would be allocated among the members.

The party unit will report the value of the use of the facility as a contribution to the elected members' campaign committees. The donation will be itemized if the value of the membership is over \$200, or if the value of the membership combined with any other donation made by the party unit to the elected member during the calendar year exceeds \$200. The elected member will also report the donation in kind from the party unit on the schedule for party unit contributions, again itemizing the contribution if the value is over \$200 either individually or in aggregate with other contributions from the party unit. A donation in kind is also reported as either a campaign expenditure or a non-campaign disbursement during the same reporting period in which it is received.<sup>3</sup>

## **Issue Two**

Does the purchase of a limited membership by a non-elected individual result in a contribution to the party unit?

## **Opinion Two**

Yes. The membership dues are payments for services provided by the party unit, and the party unit is free to use the membership dues for any political purpose. The payment of dues, regardless of whether paid for by an elected or limited member, will be reported as contributions during the reporting period in which the payment is received. Itemization of the donation will occur if the member's dues exceed \$200 in a calendar year, or if the dues in combination with other contributions to the party unit exceed \$200 during the calendar year.

The Board notes that Minnesota Statutes section 10A.271 provides that a political party unit that sells goods or services must provide notice to the purchaser that the payment for the item is a political contribution.

#### **Issue Three**

If a limited membership is purchased by a registered lobbyist prior to the beginning of the legislative session, will use of the membership during the session result in a violation of the sessional contribution prohibition?

## **Opinion Three**

No. The sessional contribution prohibition applies only to soliciting or accepting a contribution from a registered lobbyist during a regular session of the legislature. A "regular session" starts at 12:00 a.m. on the first day of each annual session and ends at 11:59 p.m. on the last day of each annual session.<sup>4</sup>

Although access to the meeting facility will be provided during a regular legislative session, the contribution occurs when payment of the membership dues is physically received by the party unit, or if the party unit accepts payment of membership dues through electronic means, on the date when the lobbyist makes the contribution.<sup>5</sup>

Lobbyists who purchase limited memberships should do so with personal funds. If the association that the lobbyist represents directly pays for the membership, or reimburses the lobbyist for the membership dues, the result will either be a prohibited corporate contribution to the party unit,<sup>6</sup> or a contribution from an unregistered association that may require underlying disclose of the source of funds used to pay the membership dues.<sup>7</sup>
