MINUTES

The meeting was called to order by Chair Rashid.

CHAIR'S REPORT

2022 meeting schedule

Going forward, the Board's regular meeting time will change to 9:30 a.m. The next Board meeting is scheduled for 9:30 a.m. on Wednesday, September 7, 2022.

REQUESTS TO ACCEPT LATE AFFIDAVIT OF CONTRIBUTIONS OR PUBLIC SUBSIDY AGREEMENT

Mr. Sigurdson presented members with a memorandum that is attached to and made a part of these minutes. Mr. Sigurdson explained that in order for candidates to receive a public subsidy payment, they must sign a public subsidy agreement and file an affidavit of contributions by the statutory deadline, as well as win any primary election. Mr. Sigurdson stated that the deadline to file a public subsidy agreement was July 19, 2022, and the deadline to file an affidavit of contributions was July 25, 2022. Mr. Sigurdson reviewed the efforts taken by Board staff to advise candidate committees of those deadlines. Mr. Sigurdson explained that in 2018 and 2020 the Board accepted affidavits of contributions that were filed after the statutory deadline due to an incorrect cross-reference within the statute that establishes the deadline for filing an affidavit of contributions. Mr. Sigurdson stated that the incorrect cross-reference was corrected in 2021.

Mr. Sigurdson explained that two candidates who filed an affidavit of contributions after the statutory deadline, Huldah Hiltsley and Shaun Laden, lost their primary election, so their requests are somewhat moot. Mr. Sigurdson stated that Brendan Van Alstyne is asking the Board to accept a late-filed public subsidy agreement and that Bradley Brown is asking the Board to accept a late-filed affidavit of contributions.

Mr. Hartshorn stated that he views the deadlines as mandatory and does not feel that it is within the Board's discretion to waive the deadlines. Chair Rashid stated that he agrees with that analysis.

Member Flynn asked whether Mr. Van Alstyne's email sent to an incorrect email address on June 24, 2022, resulted in a bounceback email informing him that his email was not successfully delivered. Mr. Sigurdson explained that such emails typically result in a bounceback email, but bounceback emails are often delivered to a user's spam folder, so the user may never realize that the original email was not delivered.

Mr. Soule stated that he believes that the Board has no discretion regarding the deadline for filing a public subsidy agreement.

No motion was made to grant any of the requests before the Board.

EXECUTIVE DIRECTOR'S REPORT

Mr. Sigurdson presented members with a memorandum that is attached to and made a part of these minutes.

Ratification of Budget for Fiscal Year 2023

Mr. Sigurdson stated that the Board is required to approve a budget for each fiscal year. Mr. Sigurdson noted that 88% of the budget goes to fixed costs involving staff and rent. Mr. Sigurdson stated that the FY2023 budget represents a 2% increase over the FY2022 budget and includes approximately \$47,000 in funds carried over from FY2022 as a result of cost savings while a staff position temporarily remained vacant.

Political Contribution Refunds in 2021

Mr. Sigurdson stated that in August of every year the Department of Revenue (DOR) provides a list of the political contribution refunds that have been issued for contributions made to political party units and to the principal campaign committees of candidates who have signed a public subsidy agreement. Mr. Sigurdson said that for the 2021 calendar year, DOR issued 31,666 refunds with a total value of approximately \$2.2 million. Mr. Sigurdson explained that approximately \$619,000 of the amount refunded was for contributions to candidates and approximately \$1,578,000 of the amount refunded was for contributions to party units. Mr. Sigurdson said that party units typically issue more political contribution refund receipts than candidates during non-election years. Mr. Sigurdson explained that 9% of contributions to RPM candidates resulted in a refund while 4% of contributions to DFL candidates resulted in a refund. Mr. Sigurdson noted that over the past two years, contributions to DFL party units have resulted in more refunds than contributions to RPM party units, whereas historically contributors to RPM party units have received more refunds than contributors to DFL party units.

Member Soule asked what drives the total amount of refunds issued. Mr. Sigurdson said that aside from the number of candidates who sign a public subsidy agreement, which is necessary in order for candidate committees to issue political contribution refund receipts, the level of refunds issued is dependent upon the number of individuals who make contributions. Mr. Sigurdson said that the proportion of contributions received by party units from individuals, as opposed to contributions from political committees or funds, has decreased. Mr. Sigurdson also stated that the proportion of contributions from individuals that consist of very large contributions has increased, which reduces the total amount of refunds issued because an individual is only eligible to receive a refund of up to \$50 per calendar year.

ENFORCEMENT REPORT

A. Consent Items

1. Administrative termination of lobbyists Kelby Grovender (4183) and Warren Duncan (2428)

Mr. Olson stated that Marcus Schmit, executive director of Hearth Connection, has requested the administrative termination of Kelby Grovender and Warren Duncan as lobbyists for that principal. Mr. Olson said that Mr. Grovender ceased being employed by the principal on December 1, 2021, and Mr. Duncan ceased being employed by the principal on October 20, 2021. Mr. Olson explained that the principal attempted to contact Mr. Grovender, who reported Mr. Duncan's disbursements, but did not receive any response. Mr. Olson said that Board staff terminated Mr. Grovender's lobbyist registration as of December 1, 2021, and terminated Mr. Duncan's lobbyist registration as of October 20, 2021. Mr. Olson explained that if the request to make the terminations retroactive is approved, there will be no outstanding disbursement reports. Mr. Olson also said that the written request from the principal states that Mr. Grovender separated from employment in 2020 rather than 2021, but Board staff has confirmed that that is a typographical error.

2. Administrative termination of lobbyists Mysti Babineau (4410), Kate Jacobson (4678), and Victoria Yarwood (5133)

Mr. Olson stated that Tee McClenty, executive director of MN350 Action, has requested the administrative termination of Mysti Babineau, Kate Jacobson, and Victoria Yarwood as lobbyists for that principal. Mr. Olson said that Ms. Babineau ceased representing the principal after July 9, 2021, Ms. Jacobson ceased representing the principal after August 13, 2021, and Ms. Yarwood ceased representing the principal on April 30, 2022. Mr. Olson explained that Board staff terminated Ms. Babineau's and Ms. Jacobson's lobbyist registration as of the dates listed above. Mr. Olson noted that the written request states that Ms. Yarwood was not a lobbyist; however, Ms. Yarwood registered as a lobbyist and filed a lobbyist disbursement report covering the reporting period that ended on December 31, 2021, disclosing over \$1,300 in disbursements. Mr. Olson stated that Ms. Yarwood registered as the principal's designated lobbyist so she was responsible for reporting the principal's direct lobbying disbursements in addition to her own disbursements. Mr. Olson explained that because Ms. Yarwood did not file a report covering the subsequent reporting period and the principal has stated that she was not acting as a lobbyist, Board staff terminated Ms. Yardoowd's lobbyist registration as of December 31, 2021. Mr. Olson said that if the request to make each termination retroactive is approved, there will be no outstanding disbursement reports.

Re: Executive Director's Report

Campaign Finance Reports: Staff is preparing to send the notice of the need to file the 4th Report of Receipts and Expenditures to 12 principal campaign committees for statewide office, 450 political committees and funds, and the 10 political party state central committees and legislative caucuses. The reports are due on September 27, and cover financial activity that occurred by September 20, 2022. Candidates for the legislature do not file this report.

Public Subsidy Payments: On August 18, 2022, the Board issued \$2,334,631 in public subsidy payments to 316 qualified candidates for constitutional office, the state senate, and the house of representatives. To qualify for a public subsidy payment the candidate must register a principal campaign committee, sign the public subsidy agreement, be opposed at either the primary or general election, win the primary election if opposed, raise a specified amount of contributions from eligible Minnesota voters, and file an affidavit of contributions stating that the candidate has raised the required amount.

The money used for the public subsidy payments comes from an appropriation of \$1,020,000 which is divided evenly among major party candidates for an office regardless of party affiliation, and from the \$5 political party check-off on the state income and property tax forms. The political party check-off money is allocated based on a formula that considers the number of taxpayers within a legislative district that select a particular party, and the preceding state general election results for the district. This results in a broad range of amounts for the political party payments depending on the relative strength of the political party in the district. For example, total public subsidy payments issued to house candidates ranged from \$2,289 to the Republican candidate in District 1A, to a high of \$7,466 issued to the DFL candidate in District 64A. For senate candidates the range was from \$4,181 paid to the Republican candidate in District 62, to a high of \$14,719 paid to the DFL candidate in District 64. The average payment to house candidates was \$6,938. A report of public subsidy payments by office, district, and party is attached to this report.

CAMPAIGN FINANCE AND PUBLIC DISCLOSURE BOARD MAKES DISTRIBUTION OF 2022 PUBLIC SUBSIDY PAYMENTS

The Campaign Finance and Public Disclosure Board distributed **\$2,334,631** in public subsidy payments to 316 candidates who are running for Constitutional Office, the State Senate, or the House of Representatives at the 2022 state general election. A list of qualifying candidates and payments is attached.

Of the 431 candidates who filed for constitutional or legislative office, 384 (89%) signed the voluntary agreement to abide by spending limits and to comply with other conditions of the agreement required under Minnesota Statutes Chapter 10A.

To qualify for a public subsidy payment a candidate must:

- be opposed at either the primary or general election,
- appear on the general election ballot (win the primary election if opposed),
- sign and timely file a public subsidy agreement with the Board to abide by applicable campaign expenditure limits,
- and sign and timely file an affidavit of contributions stating that the candidate accumulated a specified amount in contributions from individuals eligible to vote in Minnesota.

Funds for the public subsidy payment are derived from an appropriation from the state general fund that is based on the check-off included on the state income and property tax forms and an additional \$1,020,000 biennial appropriation from the state general fund. By party, the total post-primary public subsidy payments were:

Subject: Enforcement report for consideration at the September 7, 2022 Board meeting

A. Consent Items

1. Administrative termination of lobbyist Matthew Lee Bruce Sieg (4751)

Amanda Koehler, policy manager for the Land Stewardship Project, has requested the administrative termination of Matthew Lee Bruce Sieg as a lobbyist for that principal. Mr. Sieg left his role as an intern with the principal in May 2020. The principal attempted to contact Mr. Sieg to ask him to file a termination statement, but did not receive any response. Mr. Sieg has been included within the disbursement reports filed by one of the principal's reporting lobbyists, so there are no outstanding reports aside from the termination statement. Board staff terminated Mr. Sieg's lobbyist registration as of May 31, 2020.

B. Discussion Items

1. Balance adjustment request - Erina Prom for MN House (18546)

Ms. Prom was an unsuccessful candidate for state representative in 2020. Her committee's 2020 yearend report of receipts and expenditures listed an ending cash balance of \$307.19, while the committee's 2021 year-end report (amendment 2) listed a beginning cash balance of \$741, leaving a discrepancy of \$433.81. The committee's 2021 year-end report (amendment 2) listed an ending cash balance of \$740.75, while the committee's termination report filed in July 2022 listed a beginning cash balance of \$656.75, leaving a discrepancy of \$84. The committee's treasurer, Theresa Dworak, has reviewed the committee's financial records and discussed the matter with Board staff, but is unable to reconcile those discrepancies. The committee therefore is asking that its 2020 ending cash balance be adjusted upward by \$433.81 and that its 2021 ending cash balance be adjusted downward by \$84, resulting in a net upward adjustment of \$349.81.

Ms. Dworak provided bank statements showing that the balances in the committee's bank account at the end of 2020 and 2021 were \$741 and \$656.75, respectively. The committee reported \$16,967 in monetary receipts and \$16,660 in monetary disbursements in 2020. The committee's registration with the Board has been terminated.

I'm an writing in regard to a 24 hour notice non-compliance for the WESENBERG FOR SENATE account. I had a number of questions regarding large-sum loans we have to the campaign, for which I did call for assistance. I was given great information as well as directed to the videos to review for step-by-step instructions. I actually watched the videos several times to be sure I knew what I was doing and how to complete and submit reports. When I entered the large-sum loan in question (\$5000) initially I entered it as ME as the lender (figuring that out all comes from the same place, as Nathan and I are married and have joint accounts), an error popped up saying that that is not in compliance. I called and was told that the lender had to be Nathan, so I switched it to him. When I spoke to someone, I asked about a 24 hour notice, and they said they didn't think so. Submitted it, no problems. Nothing came up saying a 24 hour notice was required - promoting one be generated.

When I generated the pre-primary report, I watched the video again, and I was then checking for 24 hour notice every day, as the video suggested. I actually ended up submitted my preprimary report too EARLY so I got a call from someone explaining that it won't be accepted until the next week, so make sure all transactions are updated and resubmit then. I asked them what monetary value triggers a 24 hour notice, and I was told anything OVER \$500 in a state Senate race.

Anyway, I then submitted my pre-primary report no problem. I DAILY checked all the tabs, even though we never got >\$500 donations. Never was I instructed that I have a 24 hour notice that needs submitting.

So, after we WON the primary, I stopped doing daily checks on the computer software because I needed to focus back on my career as a physician. I knew that we hadn't received any donations anywhere near \$500. However, last week, we had just deposited a number of checks, so I figured I should get caught up on updating the system. When I logged out, the program ran a compliance report or something, and suddenly found this very outdated 24 hour notice. I know that I've run these reports in the past with a clean check, so this time to find a long-overdue notice, it made my heart drop. Anyway, I figured it who to file the report.

Now writing the committee to have you consider dropping any fines/fees associated with the late filing, as I truly was following the steps described on your videos. I asked the questions to the people I interacted with. It seems like the system betrayed me.

Please let this serve as my request for a waiver of the late filing penalty regarding the Congressional District 5 Republican Committee report (for the July 25, 2022 reporting period). I realize the report was late, for which I apologize. The reasons for our late report are as follows:

1. I am the Chair of the CD5 Committee. I have never served as a Treasurer of any committee or campaign, at any level. This was new to me.

2. Our Treasurer, who had been on the job for only three months, abruptly quit in July. We did not have a replacement, and I was forced to register as Treasurer.

3. I registered as Treasurer immediately before a planned one-week vacation. Unfortunately, I couldn't get out of taking the vacation, so I missed a week of preparation time.

4. I found that our Bank Account, our Email Account, and our Anedot (contributions) Account were all inaccessible. The Bank Account was not timely transferred over to me. When it finally was, the online account was still linked to the person who had served as Treasurer in 2021. I was unable to access the account for several days. I had a similar experience with the other two accounts, and had to track down our former IT person in order to gain access to email and Anedot. I thus didn't actually have the data for providing the report until Wednesday, August 3rd.

5. Overlaid on all of this was my unfamiliarity with the CFB Software. I had no training on the software, and finally had to manually fill in our report.

As you may have seen, there is not a great deal of money at issue; our committee operates on a shoestring. That doesn't make what happened right, but it does show that we are not dealing with significant sums. I hope the Board will consider these factors when making its decision. Thanks for your consideration.

Ms. Engelhardt and Minnesota Campaign Finance Board,

I received a letter stating that the 55th Senate District - DFL was being assessed a \$50 late fee for a late submission of the pre-primary campaign finance reports. To begin with I want to apologize that our report was not by midnight on the deadline July 25th. I realize the amount of reports state-wide that needs to be filed with the CFB at each filing deadline must be overwhelming, therefore I try not to wait until the last minute to file my reports. I can only imagine the amount of work that would go into such an ordeal to sift through, audit, and publicize all of the reports. I am sure it is to very little (if any) fanfare. I do not want to send this request for a waver without recognizing the amount of work you do, as well as recognizing the need for the deadlines and the penalty for not meeting the deadline. I completely agree with the concept and the need to have such policies in place.

The reason I write to you is to explain my situation and hope that you would be willing to forego the penalty for this instance. As a once in a decade redistricting year I am sure it creates a lot more confusion than usual especially within the Senate District political party units on who is responsible to file for which newly open and closing units, who needs to pay for what when does this new senate district begin and when does the old one end and what money goes where and how does it get split out in the end. I know the CFB tries to be on the forefront in offering training, however I am not sure everyone participates and there is a lot of miss-information spread about, which sometimes is difficult to refute and adds to the confusion. My situation had an added wrinkle because I was the Treasurer of the old Senate District 51 at the beginning of the year. As a part of the redistricting process and boundary changes, while the majority of SD-51 became SD-52; my precinct switched to the new Senate District 55 (whose boundaries basically resemble old SD-56). At the same time the outgoing treasurer of old SD-56 was planning to move out of state, and therefore was not planning to join the new senate district and I was elected to take over as the treasurer of the new SD-55. Here is where the confusion I mention above sets in. As the out-going treasurer of SD-51 I understood my duty was to close out the old Senate District disburse the remaining funds and assets as necessary to the affected new Senate Districts and submit the Termination Report to the Campaign Finance Board. I will admit it took a lot more time than I expected, however I was able to close out the old SD-51 just prior to the pre-primary deadline. The new SD-52 elected a new treasurer and established a new bank account, with a clean divide on revenue and expenses between SD-51 & SD-52. The transition between Old SD 56 & new SD-55 wasn't as smooth. There had been a lot of turn-over in the Senate District leading up to the redistricting and as I had mentioned the former treasurer was actually in the process of moving out of state. The names on the bank account were out-dated leaving the out-going Treasurer the only person who could access the funds of the old Senate District. I believe it was the outgoing treasurer's understanding that he would hand off the old treasurer's duties to me and he would be free from it and he could focus on his move out of state. in most

circumstances he would be correct, however this is where the redistricting confusion comes in. In most Treasurer turn-overs I would be the elected officer to handle the district's funds. However that wasn't the case here, I was elected as the Treasurer of the new SD 55 and was never even a part of the old SD 56 legal entity, I had absolutely no right to handle those funds. Also, since I was not on the bank account, I had no access to those funds. Therefore even after the convention there was no clean delineation between what new revenues or expenses were a part of the old Senate District and the new Senate District.

Due to his personal commitments there was a period of time when I was not able to connect with the outgoing treasurer, therefore Senate District 55 continued to operate on the limited funds we collected from the convention and waited to finalize on some outstanding expenses until we received the bulk of our funds when the old Senate District was finally terminated.

The out-going treasurer and I were finally able to connect about mid-July to close out the old bank account and disburse the funds. However, since we were operating without the bulk of our funds for so long we had to coordinate on the reporting for pre-primary reporting and worked together as much as we could up to and including the 25th itself. I ended up working on my report well into the night, hoping we were both on the same page as far as deciphering which expenses and revenues should be reported by which entity. It was about an hour and a half after midnight on the night the report was due that I finally comfortable submitting my report.

To summarize; I appreciate the necessity of requiring a reporting deadline and the need to enforce that deadline with penalties for delinquent reports. In consideration of waving the penalty I hope Campaign Finance Board is willing to consider the uniqueness of this particular reporting deadline in how it interacts with the once in a decade re-alignment of the senate districts, the changing of bank accounts and in our case - for all intents and purposes - the change over of treasurers. I would also point out due to where it falls in the the redistricting timeline that this is probably the most complex of any other filing deadline done by the political party units. Obviously some turn-overs run more smoothly then others, however especially in the given circumstances some have more complexities then others, I believe ours falls within the latter category. Coupled with the fact that my report was still actively in process at the time of the deadline - submitted only an hour and a half past due - I would respectfully request the Campaign Finance Board to wave the \$50 penalty for the 55th Senate District-DFL for this one missed reporting deadline.

Re: Prima facie determination finding no violation

Complaints filed with the Board are subject to a prima facie determination which is usually made by the Board chair in consultation with staff. If the Board chair determines that the complaint states a violation of Chapter 10A or the provisions of Chapter 211B under the Board's jurisdiction, the complaint moves forward to a probable cause determination by the full Board.

If the Board chair determines that the complaint does not state a prima facie violation, the prima facie determination must dismiss the complaint without prejudice. When a complaint is dismissed, the complaint and the prima facie determination become public data. The following complaint was dismissed by Chair Rashid and the prima facie determination is provided here as an informational item to the other Board members. No further action of the Board is required.

Complaint regarding the Scott County RPM and Joseph Ditto

On August 22, 2022, the Board received a complaint submitted by Bob Foster regarding the Scott County RPM and Joseph Ditto. The complaint alleged that the Scott County RPM had violated Minnesota Statutes sections 211B.02 (false claim of support), 211B.06 (distribution of false campaign material), 10A.176 (expenditures coordinated with a candidate) and 10A.20 (information in campaign reports).

On August 31, 2022, Chair Rashid concluded that the Board does not have jurisdiction over the violations of Chapter 211B alleged in the complaint, and that the complaint did not state a prima facie violation of either Minnesota Statutes sections 10A.176 or 10A.20. Therefore, the complaint was dismissed.

PRIMA FACIE DETERMINATION

IN THE MATTER OF THE COMPLAINT OF BOB FOSTER REGARDING THE SCOTT COUNTY RPM AND JOSEPH DITTO

On August 22, 2022, the Campaign Finance and Public Disclosure Board received a complaint submitted by Bob Foster regarding the Scott County RPM and Joseph Ditto, who is a former chair of the Scott County RPM. The Scott County RPM is a political party unit registered with the Board.

The complaint alleges that the Scott County RPM violated four provisions of Minnesota Statutes Chapters 10A and 211B. The complaint alleges that the Scott County RPM violated Minnesota Statutes section 10A.176 (activities that show expenditures are coordinated with a candidate) because the party unit did not have authority to make a coordinated expenditure supporting a candidate not endorsed by the Republican party, specifically Representative Erik Mortensen. The complaint further alleges that the party unit violated Minnesota Statutes section 10A.20 (information in campaign reports) when it failed to list an itemized in-kind contribution for the use of the fair booth by Representative Mortensen within its 2022 pre-primary report of receipts and expenditures. The complaint also states that the Scott County RPM violated Minnesota Statutes section 211B.02 (false claim of support), when the party unit let a candidate who was not endorsed by the Republican party distribute literature at the party unit's booth at the Scott County Fair. The complaint alleges that the Scott County RPM issued a press release that contained false statements about candidate Bob Loonan that violated Minnesota Statutes section 211B.06 (distribution of false campaign material). Lastly, the complaint alleges that the party unit also violated Minnesota Statutes section 211B.06 by allowing Representative Mortensen to use its booth at the Scott County Fair to disseminate false campaign material.

In support of the allegations the complainant provides photos of the party unit's booth at the Scott County Fair. The photos show campaign literature and signs for candidates available at the booth, including what is alleged to be literature for the Mortensen committee. The complaint also provides a picture of a water bottle allegedly given away at the booth with a "Mort for House" sticker attached. The complaint included copies of a Facebook post allegedly made by Representative Mortensen dated July 29, 2022, promoting times when he would be at the Scott County RPM fair booth, and a Facebook post by the Scott County RPM dated July 31, 2022, that generally promoted the booth at the fair. The complaint also provided a copy of a Scott County RPM press release dated August 3, 2022.

Determination

The Board's jurisdiction over Minnesota Statutes Chapter 211B is limited, and does not extend to sections 211B.02 and 211B.06. Complaints regarding those two statutes must be filed with the Office of Administrative Hearings.¹ Minn. Stat. § 211B.32, subd. 1. The allegations in the complaint regarding a false claim of support and false campaign material therefore do not state a prima facie violation of Minnesota Statutes Chapter 10A or of those sections of Chapter 211B under the Board's jurisdiction.

Minnesota Statutes section 10A.176 describes relationships and communication between a candidate and or the candidate's committee and a political committee, political fund, or political party unit that would constitute a coordinated expenditure. Coordination with a candidate is not prohibited by this statute. The provisions of the statute are used to distinguish approved expenditures on behalf of a candidate from independent expenditures. The complainant appears to state that coordination between a party unit and a candidate that is not endorsed is a violation of this statute; however, a party's endorsement is irrelevant to the statute, and there is no means by which an individual or association may violate the statute because the statute does not prohibit any particular activity. The complaint therefore does not state a prima facie violation of Minnesota Statutes section 10A.176.

Minnesota Statutes section 10A.20 provides reporting requirements for political party units registered with the Board. The statute establishes filing deadlines for periodic reports that disclose, in part, the itemized contributions made to candidates for state office. Itemization is required when the cumulative contributions to a candidate exceed \$200. Each report discloses the party unit's financial activity for a specific period of time. As of the date of this prima facie determination the party unit has been required to file only one report in 2022, the pre-primary report, which covered financial activity during the period of January 1 to July 18, 2022.

The complaint points out that on its pre-primary report the Scott County RPM disclosed an expenditure on May 4, 2022, of \$600 to the Scott County Fair for rental of the booth. The complainant alleges that the report should have also itemized an in-kind contribution to the Mortensen committee for use of the fair booth. However, the complaint does not reference any specific evidence that the party unit rented the fair booth with the understanding that it would be an approved expenditure (a type of in-kind contribution) on behalf of the Mortensen committee or any other candidate. The photographs of the fair booth provided as evidence appear to show a banner and material promoting the Scott County RPM, along with campaign signs and/or campaign literature for at least twelve other candidates besides Representative Mortensen. The committees that provided literature or campaign signs to the Scott County RPM for display at the fair booth would have received an in-kind contribution consisting of the value of use of some area of the booth during the dates of the fair, which occurred from July 27 to July 31, 2022.

¹ The website of the Office of Administrative Hearings states that it "may not consider and must dismiss claims alleging violations of Minn. Stat. § 211B.06 (false campaign material); the United States Court of Appeals for the Eighth Circuit determined that statute was unconstitutional in 281 Care Committee v. Arneson."

These dates are after the period of activity included in the pre-primary report. To the extent that the use of the fair booth was a reportable in-kind contribution from the Scott County RPM to the Mortensen committee it would not be disclosed until the pre-general report, which is due on October 31, 2022, and includes activity from January 1 to October 24, 2022. Having concluded that an in-kind contribution for use of the fair booth did not need to be included in the pre-primary report, this prima facie determination need not consider whether the alleged contribution exceeded the \$20 threshold for accounting of in-kind contributions, and if so, whether the contribution requires itemization. The complaint therefore does not state a prima facie violation of the reporting requirements in Minnesota Statutes section 10A.20.

Pursuant to Minnesota Statutes section 10A.022, subdivision 3, paragraph (c), this prima facie determination is made by a single Board member and not by any vote of the entire Board. Based on the above analysis, the Chair concludes that the complaint does not state a prima facie violation of Chapter 10A or of those sections of Chapter 211B under the Board's jurisdiction. The complaint is dismissed without prejudice.

Minnesota Statutes section 10A.022, subdivision 3, describes the procedures required for investigating complaints. A full description of the complaint process is available on the Board's website.

Briefly, the Board will notify you when it has received your complaint. The Board must send a copy of the complaint to the respondent. Complaints and investigations are confidential. Board members and staff cannot talk about an investigation except as required to carry out the investigation or to take action in the matter. After the Board issues a decision, the record of the investigation is public.

The law requires a complaint to go through two stages before the Board can begin an investigation: a prima facie determination and a probable cause decision. If the complaint does not pass one of the stages, it must be dismissed.

The Board has 10 business days after receiving your complaint to determine whether the complaint is sufficient to allege a prima facie violation of the campaign finance laws. If the Board determines that the complaint does allege a prima facie violation, the Board has 45 days to decide whether probable cause exists to believe a violation that warrants a formal investigation has occurred. Both you and the respondent have the right to be heard on the issue of probable cause before the Board makes this decision. The Board will notify you if the complaint moves to the probable cause stage.

If the Board determines that probable cause does not exist, the Board will dismiss the complaint. If the Board determines that probable cause exists, the Board will start an investigation. The Board will send you monthly updates regarding the status of the investigation. At the end of the investigation, the Board will offer you and the respondent the opportunity to be heard before the Board makes a final decision.

In most cases, the Board will issue findings, conclusions, and an order as its decision. For a spending or contribution limits violation, the Board can enter into a conciliation agreement with the respondent instead of issuing findings, conclusions, and an order. The Board's final decision will be sent to you and posted on the Board's website.

10A.176 COORDINATED EXPENDITURES. Sec. 10A.176 MN Statutes

Scott County RPM provided access to a paid fair booth. The Scott County RPM did not have authority to act on behalf of the party unit and therefore not deemed a party unit expenditure, violating Sub 7 (1) and (2), Candidates Participation. Candidate and Scott County RPM coordinated booth time to speak and distribute materials. Materials included campaign literature and water bottles with campaign logos. (See attached pictures) This would have otherwise come at a cost to the candidate.

211B.02 FALSE CLAIM OF SUPPORT Sec. 211B.02 MN Statutes

The Scott County RPM cannot directly or indirectly claim support for candidate Erik Mortensen by allowing the use of the Scott County Fair booth. As the constitution of the organization clearly states, the Scott County RPM can only support endorsed candidates. By use of the booth they have made a false claim of support, which was not granted by the delegates.

211B.06 FALSE POLITICAL AND CAMPAIGN MATERIAL (Gross Misdemeanor) Sec. 211B.06 MN Statutes

The Scott County RPM made statements in a press release which were false. Bob Loonan does not have a repeated history of Campaign Finance violations. Records show one claim by Erik Mortensen was dismissed in 2020 and no violations on the board enforcement actions log for 2018, as stated in the press release.

211B.06 FALSE POLITICAL AND CAMPAIGN MATERIAL (Gross Misdemeanor) Sec. 211B.06 MN Statutes

By allowing use of the Scott County Fair Booth, Scott County RPM falsely participated in the dissemination of campaign materials. Erik Mortensen was not endorsed at the HD54A convention as the delegates voted to not endorse for the HD 54A primary ballot question. Under the terms of its governing constitution, <u>"To comply with Article V, Section 3.A.6 of the</u>

<u>Republican Party of Minnesota Constitution, it is the duty and responsibility of the Scott County</u> <u>GOP to only support the election of endorsed Republican candidates at the state....</u>" the Scott County RPM did not have the authority support candidate Mortensen and therefore is falsely claiming endorsement support.

10A.20 CAMPAIGN REPORTS Sec. 10A.20 MN Statutes

The Scott County RPM did not disclose the itemized campaign expense in supporting Erik Mortensen. A payment was made on 5/4/2022 to the Scott County Fair but no "In Kind" contribution was reported in the required Schedule B2A-PCC Direct Contributions to Candidate Committees. Since the Scott County RPM was unable to support the candidate as part of normal operating expenses as shown, the Scott County RPM can only support the election of endorsed Republican candidates.



Criminal Bob Loonan GUILTY Again

Shakopee, Minn. – Today the Office of Administrative Hearings found Bob Loonan GUILTY after a full hearing of the evidence about his criminal activity which violated the Fair Campaign Practices law. The Fair Campaign Practices law aims to protect individuals and entities from those making fraudulent claims of being endorsed by candidates or their surrogates that are not officially endorsed. He must pay a fine by Sept. 2, 2022.

On June 18th, 2022, Bob Loonan was busted breaking the Fair Campaign Practices law fraudulently claiming he was endorsed by the Republican party and distributing literature trying to deceive Republican voters when he was NOT endorsed. He also falsely claimed he was up for re-election when he had not been in elected office for years, being rejected by voters over and over again. "Today justice was served and the rule of law upheld against the repeat violator Bob Loonan." Scott County GOP Spokesman Dale Even said.

Bob has been known for violations of Campaign Finance laws in 2018; fined \$10,000 for falsifying educational hours in 2015; and suspended from being allowed to teach education classes by the Minnesota Department of Commerce and yet again just months ago Bob was again fined another \$10,000 by the Minnesota Department Commerce for insurance class violations.

Now Bob has been found GUILTY of breaking the Fair Campaign Practices Laws. Bob's failed defense by his high-priced, unsuccessful lawyer, Rondell Reid LeBeau II, attempted to brush off the issue and demand lawyers fees. "After multiple reviews by judges who considered if there were prima facie violation and probable cause, a three judge panel saw right through Bob Looan and his lawyers' weak and unsupported defense. Ultimately Bob was found GUILTY of violating the Fair Campaign Practices laws," Dale stated.

"This shows that average, everyday working people can hold the Political Class and politically well-connected accountable for their corrupt ways," said Jim Krause, Director At-Large for the Scott County GOP, who filed the complaint with the Office of Administrative Hearings as required by law.

From the FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER:

"Complainant established by a preponderance of the evidence that Respondent disseminated or was responsible for the dissemination of the campaign material observed at homes in the Shakopee area on June 18, 2022. Complainant established by a preponderance of the evidence that Respondent violated Minn. Stat. § 211B.02, by knowingly and falsely implying that he had the endorsement of the Minnesota Republican Party and the Minnesota Chamber of Commerce. Complainant established by a preponderance of the evidence of the evidence that Respondent violated Minn. Stat. § 211B.03, by using the term "re-elect" in a campaign for elective office on or about June 18, 2022."

"We've stated from the beginning that we would hold Bob accountable for major violations of the Fair Campaign Practices laws, for fraudulently claiming our endorsement and his damaging and illegal behavior of deceiving Republicans. The rule of law has prevailed and Bob has been held to account." Dale concluded.
