MINUTES

The meeting was called to order by Chair Asp.

Members present: Asp, Banaian, Flynn, Rashid, Spevacek, Swanson

Others present: Sigurdson, Engelhardt, Olson, Lohse, staff

The meeting did not follow the order of business stated in the agenda with respect to consideration of the order of the Enforcement Report and the Legal Report.

MINUTES (February 4, 2026)

The following motion was made:

Member Rashid's motion: To approve the February 4, 2026, minutes as drafted.

Vote on motion: Unanimously approved.

CHAIR'S REPORT

Mr. Sigurdson noted the April 1st meeting may occur in the afternoon as the Stassen Room was not available in the morning, and encouraged members to reach out if personal scheduling conflicts precluded an afternoon meeting time.

EXECUTIVE DIRECTOR'S REPORT

Mr. Sigurdson reported the successful confirmations of Members Banaian and Swanson. Mr. Sigurdson provided legislative updates on three bills under consideration that would impact the Board. The bill related to the Board's recommended language updates, Senate File 4223, is on track to approval. The other two bills being considered originate from court decisions about disclosure of grassroots lobbying expenditures by principals and prominence requirements for disclaimers on campaign material. Both of these bills are likely to be part of the Senate omnibus elections bill. On the House side, both are being sponsored by Representative Freiberg though considered separately. Chair Asp asked if the bill related to grassroots lobbying would effectively resolve the outstanding issues in the federal litigation. Mr. Sigurdson responded he believed it would. Chair Asp further inquired if Mr. Sigurdson believed the bill addressing disclaimers would be settled

quickly. Mr. Sigurdson expressed confidence that the Legislature would act on the matter and until such legislation was passed, the matters remanded by the Court of Appeals could be laid over. Mr. Sigurdson also provided information on a bill that would authorize a pilot program for a trimmed-down version of the CFRO program to be made available to local candidates and another bill that would limit access to street addresses within reports filed with the Board.

ENFORCEMENT REPORT

The Board heard from Kim Vera, Chair of the 34th Senate District DFL in relation to the group’s waiver request.

Treasurer Sandy Beeson states the late filing of the report was due a misunderstanding of the language used on the CFRO website. They thought the report had been “Uploaded” without realizing they needed to click a button file the report. The language used in the waiver request does not match CFRO. There is no language in CFRO stating that anything has been “Uploaded” and in order to file a report, all that is required is that the treasurer check a box certifying the report is accurate, then click a button labeled “Submit”. This committee filed 7 previous reports using CFRO, and the process is the same that was used in the old Campaign Finance Reporter software. The committee has been registered with the Board since 1974 and hasn’t had a late filing fee since 2018.

<p>Current Treasurer Matthew Sundeen stated the ballot question political fund was formed to pass a levy referendum question for Roseville Area Schools ISD 623. The group originally planned to rely on two in-kind mailer donations from Education Minnesota PAC and another in-kind donation of yard signs paid for by community members, all totaling under the \$5,000 registration threshold for ballot question funds. The group ultimately exceeded the threshold when Education Minnesota PAC accidentally sent out a third mailer just before election day, and Mr. Sundeen was unable to undertake corrective steps until November 3rd.</p>

<p>Kristin Landry of Kyros Recovery states the late filing arose from significant organizational disruption during the relevant period. Effective September 2024, the employees responsible for overseeing and submitting lobbying activity reports were no longer employed by the company. Shortly thereafter, in November 2024, the company was placed into receivership. During receivership, operational control and administrative functions were significantly limited and transitional in nature. In May of 2025, the company was acquired by a new entity and Kyros is no longer a lobbyist principal. Kyros was referred to the Attorney General’s Office in July 2025 and served with a summons and complaint in January 2026, at which point the report was quickly filed.</p>

<p>Treasurer John Arlandson states the first late notice was an oversight on his part due to his lack of familiarity with the 24-hour requirement. The second late notice was due to a miscommunication with Education Minnesota regarding their in-kind contribution in late October. Treasurer Arlandson spoke with Board staff about the oversight and, based on that conversation, understood the filing would be compliant but realizes he was not correct. The first late filing fee was assessed in error. While the fund received a large contribution during a large contribution notice period, it wasn’t required to file that notice because it didn’t cross the \$200 spending threshold that triggers reporting requirements in odd-numbered years until late September.</p>					

Chair Asp asked for clarification as to whether or not Dr. Alm was still serving on the Medical Services Review Board. Re: Executive Director's Report – Board Operations

Lobbyist Principal Report

The Annual Principal Report, which disclosed total expenditures on lobbying during 2025, was due on March 16, 2026. As of the date of this memo, reports have been received from 1,756 of the 1,797 principals required to file. The reports filed so far disclose that **\$95,085,254** was spent in 2025 to lobby in Minnesota. This amount includes the compensation paid to lobbyists, and costs incurred to support lobbying. Principals report the amount spent in the following four categories.

- The amount spent to influence actions by the Minnesota Public Utilities Commission (PUC) in cases of rate setting, power plant and power line siting, and granting of certificates of need. PUC commissioners cannot participate in ex parte communications (they cannot meet privately with lobbyists on an issue before the commission), so the amount reported for lobbying is the cost of participating in public hearings held by or for the PUC. Lobbyist principals reported spending **\$11,241,568** to influence the actions of the PUC.
- The amount spent to influence legislative action, which includes attempts to influence the Governor or other constitutional officers to support or oppose legislation, is currently reported as **\$79,338,569**.
- Principals reported they spent **\$1,756,448** to influence administrative action. Administrative action is when a state agency adopts, repeals, or modifies administrative rules. Attempting to influence the application of existing administrative rules by a state agency is not considered lobbying.
- Principals reported that **\$2,748,669** was spent to influence the actions of political subdivisions. The scope of this category changed significantly on June 1, 2025. Prior to that date lobbying of local government only included the seven counties in the metropolitan area, cities with a population of 50,000 or greater in the metropolitan area, and metropolitan governmental units like the Metropolitan Council. Starting June 1 of last year, this category includes attempts to influence the official actions of all counties, cities, townships, school districts, metropolitan governmental units, and other local government bodies. The reported expenditures for this category may increase significantly in the future when it reflects a full year of activity.

Below is a table showing the total spending reported on the Annual Principal Reports for the last ten years. A principal is permitted, but not required, to round the amount reported to the nearest \$5,000.

Legislative Action

The first deadline for legislative action is Friday, March 27. By that date committees must act favorably on bills in the house of origin and committees must act favorably on bills, or companions of bills, that met the first deadline in the other body. The Easter/Passover break for the legislature starts on March 27 at 5:00 p.m. and the legislature will be in recess until April 7. With this calendar in mind, the following bills appear to have support and are moving forward.

[SF 4223](#) Authors Sen. Westlin, Sen. Koran. This bill was the Board’s administrative recommendations bill, but it was recently turned into the omnibus policy bill for the Senate Elections Committee. It still contains the technical/noncontroversial recommendations of the Board. In addition, as the omnibus bill, the following provisions are also included in the bill.

- The Board’s recommendations to remove the reporting of grassroots lobbying expenditures from the principal report, and to create a disclaimer requirement for grassroots lobbying material.
- The Board’s recommendation that the legislature establish standards for the size of disclaimers on signs.
- Provisions from Sen. Boldon’s SF 3823 that expands the requirement to file economic interest statements to all local officials, and to all candidates for local office. The statements are filed with the political subdivision, but the Board would be the enforcement agency if an individual fails to file the statement.
- Provisions from Sen. Marty’s SF 4223 that changes what is otherwise an electioneering communication into an approved expenditure for a candidate if there is coordination with the candidate.

- Provisions from Sen. Marty's SF 3886 that amend the disclaimer requirements for campaign material. In most cases the disclaimer would need to state "Paid for by.." but would no longer state that the committee "prepared" the communication. Allows a committee to provide an actively monitored email address as an alternative to a mailing address. Requires that electronic communications include a disclaimer, or if technologically infeasible to provide the full disclaimer, include the name of the person who paid for the communication, and a link to a full disclaimer.
- Requires the Board to study and report to the legislature on the public subsidy program and spending limits used in the state. This is from Sen. Boldon's SF 1915.
- Requires the Board to conduct a pilot project in which candidates for local office file campaign finance reports on a version of the online reporting application operated by the Board. The pilot must include at least four local jurisdictions, at least two from greater Minnesota, and the pilot will occur at the 2028 election. This is from Sen. Koran's SF 4086.
- Creates a working group on local candidate finance reporting. The working group would meet to examine the issue, and make recommendations to the legislature, on whether all local candidate finance reports should be filed with the Board. The working group would also examine the impact on the Board if it was the entity responsible to support local candidates. The work group would include legislators, members of local government organizations, and the executive director and two members of the Campaign Finance Board. The work group must finish its work no later than January 15, 2027. This is from Sen. Boldon's SF 828.
- Provides that street address information on individuals submitted to the Board on reports or other filings are generally classified as private data. The Board is authorized to modify a report or statement to remove private or nonpublic data. This is from Sen. Westlin's SF 3710.
- Modifies the noncampaign disbursement category for security for a candidate to include up to \$25,000 in security services, including security services provided by a political party unit as an in-kind donation. Also expands multicandidate political party expenditures to include security services provided to three or more candidates. This section of the bill would eliminate the need for the Board to adopt administrative rules to reflect the conclusions in Advisory Opinion 468. This is from Sen. Westlin's SF 3710.
- Requires the Board to take down from the website all campaign finance reports and economic interest statements until private information has been redacted or omitted from the report. The Board is provided an order of priority on which reports to work on first, and is directed to have reports filed after January 1, 2022, modified and reposted within six months after final enactment of the bill. This is from Sen. Westlin's SF 3710.

[SF 4196](#) Authors Sen. Port, Sen. Boldon. The bill establishes higher penalties for late reports, late registrations, and false certification of reports and statements. The bill was passed by the Elections Committee and sent to Judiciary. The Judiciary committee had a number of questions and concerns, and the bill was laid over. Provisions of the bill include:

- An enhanced penalty for late reports filed by committees that report \$250,000 or more of either total contributions or total expenditures, or for a committee that reports \$25,000 or more of new contributions or expenditures that occurred since the last report reporting

period. A committee that meets the thresholds for an enhanced penalty will be fined ten percent of total contributions or total expenditures (whichever is greater) for each day the report is late, up to 100% of the reported amount. The Board has no discretion in applying this penalty. The enhanced penalty does not apply to a year-end report.

- In addition, if the committee has previously been assessed an enhanced late filing fee once during the prior four years the Board may impose a late fee and civil penalty of up to twice the amount otherwise authorized. If the committee has been assessed an enhanced late filing fee more than twice during the prior four years, the late filing fee or civil penalty imposed maybe three times the amount otherwise authorized.
- An association that makes independent expenditures without first registering a committee or fund with the Board is subject to a penalty of up to four times the cost of the independent expenditures, or ten time the cost of the independent expenditures if the failure to file was intentional.
- The penalty for a treasurer that fails to maintain financial records for the committee is currently \$3,000. The bill would change the penalty to four times the amount that cannot be documented with the committee's financial records. The penalty for failure to maintain financial records would also apply to the committee of the treasurer.

[SF 3644](#) Authors Sen. Draheim, Sen. Westlin. Passed out of the Elections Committee as amended, has had a second reading. The bill provides that an economic interest statement must include each digital asset with a value of more than \$10,000. In addition, the bill provides that the economic interest statement must include each purchase or sale of stocks, stock options, or digital assets that occurred during the reporting period. The companion for this bill is HF 4138, which has not been heard in committee.

In the House it appears that the Elections Committee will not have an omnibus bill, or at least not for campaign finance-related legislation. The following bills have been heard in committee.

[HF 4243](#) Author Rep. Freiberg. This is the Board's administrative recommendations bill. The bill was passed out of the Elections Committee to the floor on March 23.

[HF 4239](#) Author Rep. Freiberg. This is the Board's recommendation on disclosure for grassroots lobbying and creating a standard for campaign disclaimers on signs. The bill was passed out of the Elections Committee to the floor on March 23.

[HF 3719](#) Author Rep. Gordon. This bill requires the Board to conduct a pilot project in which candidates for local office file campaign finance reports on a version of the online reporting application operated by the Board. This is the companion to SF 4086, the text of which is in the Senate omnibus bill. The bill was passed by the Elections Committee on March 12.

[HF3363](#) Authors Rep. Freiberg, Rep. Rehrauer, Rep. Kotyza-Witthuhn. This bill provides that street address information on individuals submitted to the Board on reports or other filings are generally classified as private data, and requires the Board to modify reports and statements on the website to remove private or nonpublic data. This is the companion to SF 3710, the text of which is included in the Senate omnibus bill. The bill was passed by the Election Committee and referred to the Judiciary and Civil Law Committee on March 9.

Ms. Engelhardt,

I am writing to request a waiver of the fee associated with the late filing of an IE committee contribution disclosure statement. In December, 2023, CTUL Action Fund made a contribution to the CTUL Action Fund Political Committee. Initially, we did not think we needed to provide a disclosure statement, as the contribution amount was less than \$5,000, and we had submitted a previous disclosure statement earlier in the year. When I learned yesterday that we do in fact need to file a disclosure statement, I immediately called your office to find out how to remedy the error and submitted the necessary information.

We understand now that the disclosure statement is required when the aggregate contribution from a source exceeds \$5,000. We are requesting a waiver for this one time error in our reporting.

Re: Request for Waiver of Late Filing Fee and Civil Penalty – 2025 Economic Interest Statement

Dear Board Staff:

On March 20, 2026, I became aware for the first time that a 2025 Annual Statement of Economic Interest (“EIS”) remained outstanding in connection with my prior service at the Minnesota Department of Employment and Economic Development (“DEED”).

I submitted the EIC on March 24, 2026, and respectfully request a full waiver of the assessed late filing fee (\$100) and civil penalty (\$1,000) for the reasons explained below.

This late filing did not result from any neglect or disregard of my obligations. Rather, as confirmed by the Board’s own correspondence (attached as Exhibit A), the delay was caused by administrative and communication failures outside of my control. Specifically:

- The Board’s Agency Certification process for DEED did not function properly due to staff turnover and outdated contact information;
- The 2025 Agency Certification was mailed to an incorrect address; and
- The Board did not have an accurate or current non-state email address for me after my departure from state service.

As a result, I did not receive notice of my filing obligation or any follow-up communications prior to the assessment of penalties. I have not received any requests for completion since leaving state service in early 2025. I instead learned of the issue through a third party.

Upon learning of this issue, I acted promptly to complete and submit the required EIS. At all relevant times, I have acted in good faith and have not attempted to evade any reporting obligation.

Under these circumstances, imposition of penalties would not serve the purposes of the reporting requirements. The delay was not willful, did not result in any concealment of information, and was directly attributable to administrative errors acknowledged by the Board. I respectfully request that the Board exercise its discretion to waive both the late filing fee and the civil penalty in full.
