**SUBJECT:** 2020 Campaign Expenditure Limits

### **Expenditure Limits:**

The attached list provides the expenditure limits in effect for the two-year election segment ending in 2020, for candidates for State Senate, and State House of Representatives who will appear on the ballot at the state general election.

**Base Expenditure Limit:** Only applies to candidates who sign and timely file a public subsidy agreement, are not first-time candidates, and who were not in a closely contested primary.

**First Time Running for Office:** Applies to candidates who are running for an office for the first time and who have not run previously for any other office whose territory now includes a population that is more than one-third of the population in the territory of the new office. A candidate who qualifies as a first-time candidate receives a 10% increase in the base expenditure limit for the election segment.

**Closely Contested Primary:** Applies to winning candidates in contested primaries who received fewer than twice as many votes as any opponent in the primary. These candidates receive a 20% increase to the base expenditure limit. A candidate who is both running for the office of the first time and who won a closely contested primary receives both increases to their election segment spending limit.

**Adjusted Spending Limit:** The final expenditure limit for the candidate's campaign. The adjusted spending limit reflects any increase(s) in the expenditure limit for which the candidate qualifies.

Candidates who did not sign the public subsidy agreement are listed with "**No Limit**". Candidates who are listed as "**Limit Waived**" signed the public subsidy agreement but have been released from their spending limit because they have an opponent at the state general election who: 1) did not sign the public subsidy agreement and 2) reached certain contribution or expenditure thresholds.
