## Registration and Statement of Organization Ballot Question Political Committee or Political Fund

under Minn. Stat. § 10A.14

### Instructions

- A ballot question political committee or fund is required to register with the Board within 14 days after the committee or fund raises or spends in excess of \$5,000, and is required to amend the registration within 10 days after any change in previously filed information.
- Unless otherwise noted, all sections must be filled in before the committee or fund can be registered.

### Type of entity (check one)

- Ballot Question Political Committee - An association whose major purpose is to promote or defeat a ballot question and only makes expenditures to promote or defeat a ballot question.
- Ballot Question Political Fund - An accumulation of money by an association that has a major purpose not related to elections if the money is used only to make expenditures to promote or defeat a ballot question.

Ballot question political committees and funds may accept corporate contributions, but cannot make contributions to state or local candidates, political party units, or general purpose political committees and funds. If you wish to make contributions to those types of entities and will not accept corporate contributions, do not use this form, and instead use the registration form for general purpose political committees and funds. Ballot questions include any question on the ballot that may be voted on by voters throughout Minnesota, or by voters within a specific county, city, school district, township, or special district.
