Overview of Expenditures and Sources of Funding for the 2020 Election

Executive Summary

The Campaign Finance and Public Disclosure Board is charged with providing the public with information on the money raised and spent to influence elections for state offices in Minnesota. This is accomplished through the registration and reporting requirements of Chapter 10A, which requires candidate committees, political parties, and political committees and funds to file periodic reports of their financial activity with the Board. When filed, all campaign finance reports are available for inspection on the Board's website. Placing the reports on the website allows members of the public to quickly inspect the disclosure of candidates in their legislative districts and in other races of interest. But the volume of these reports, over 6,175 reports and amendments filed in 2020, can make it difficult for an individual to make comparisons across districts, or to see the bigger picture on how money is raised and spent to influence Minnesota elections. The goal of this overview is to reduce the data from the 2020 election into tables and graphical representations that are more approachable and that provide comparisons and summary information that would take time for individuals to generate on their own.

This overview does not replace the Campaign Finance Election Summary, which provides a detailed listing of the money raised and spent by each registered committee. The Campaign Finance Election Summary is available online at <u>cfb.mn.gov/publications/programs/reports/campaign-finance_summaries</u>. The data used for this overview is as reported to the Board. The data reported to the Board is subject to amendment. Amendments are filed to correct 2020 reports throughout the following year, and totals in this overview may differ somewhat from totals reported in the Campaign Finance Election Summary as the documents are compiled and released independent from each other.

The overview shows that total expenditures to influence the 2020 state legislative elections, counting both campaign expenditures made by the candidates' campaign committees and independent expenditures made for and against candidates, came to \$39,172,416. Starting on page 4, the overview first compares the amount spent by candidates and the amount spent on independent expenditures, then provides maps that compare the total expenditures on campaigns between districts. More detailed information is provided for each house district (Appendix A, page 16) and senate district (Appendix B, page 83). The overview also provides a relative comparison of the spending on senate and house district elections in tables that list total spending in descending order from the most expensive to the least expensive election (senate districts in Appendix C, page 117, and house districts in Appendix D, page 119). The amount spent for senate elections ranges from a high of \$2,505,711 for Senate District 34, to a low of \$21,404 for Senate District 52. For house elections the range is a high of \$678,504 in House District 33B, to a low of \$6,151 in House District 65B.

Independent expenditures made in 2020 are looked at in more detail starting on page 8. Independent expenditures made in 2020 to influence state elections totaled \$26,250,716. This section includes maps for the senate and house that identify the districts in which independent expenditures exceeded candidate campaign expenditures.

The sources of funding for candidate committees, political party units, political committees and funds, and independent expenditure committees and funds, is compared starting on page 11.


Finally, on page 14, the overview provides a brief look at the role of large contributions of over \$50,000 in the funding of political committees and funds, independent expenditure committees and funds, and political party units in 2020.


Total Expenditures to Influence the 2020 Election

Expenditures to influence voting in the 2020 elections are reported to the Board in two ways. First, candidate committees report campaign expenditures made by those committees. This amount includes the value of in-kind expenditures made with the knowledge and on behalf of a candidate by party units or political committees or funds.

Second, political parties, political committees and funds, and independent expenditure committees and funds can make independent expenditures either in support of or in opposition to candidates. Independent expenditures are made without the prior knowledge of candidates, and so are reported only by the party units and political committees and funds that made those expenditures.¹

During 2020, campaign expenditures made by the committees of house and senate candidates and independent expenditures made in support of or opposition to those candidates totaled \$12,921,699;total independent expenditures came to \$26,028,348. As seen in **Figure 1**, the 2020 election was the fourth state election in which total independent expenditures exceeded total candidate campaign expenditures. The 2020 election was the first election at which independent expenditures were not uniformly made across all elections. Independent expenditures exceeded candidate expenditures in 16 of 67 senate contests, and in only 31 of 134 house districts. Maps showing the location of districts where independent expenditures exceeded campaign expenditures exceeded campaign expenditures exceeded campaign expenditures in 11.





The Board notes that the contributions and expenditures included in this report are those contributions and expenditures reported to the Board. There are expenditures for other types of communication that

¹ Candidate committees may also spend funds on non-campaign disbursements, which are defined in statute and not counted as campaign expenditures. Party units and political committees also have general expenditures, typically administrative overhead, which are not made on behalf of a particular state candidate. Non-campaign disbursements and general expenditures are not included in this analysis.

may also influence elections that are not reported to the Board. Under current law, communications that do not use specified words that expressly advocate for or against a specific candidate are outside of the definition of independent expenditure, and are therefore outside of the reporting requirements of Chapter 10A.

Independent expenditures that total over \$200 are reported with information that identifies the candidate who was the subject of the independent expenditure, and whether the expenditure was in support of or in opposition to the candidate². Total spending on any particular race may be determined by combining the campaign expenditures made by the candidate committees in the race with the independent expenditures made for and against the candidates in that race. In **Table 1**, the ten Senate districts with the highest total expenditures in 2020 are listed.



Senate districts 34, 56, 26, and 39 are the first legislative races in Minnesota where the expenditure total exceeded two million dollars during a single year. A complete listing of total expenditures for all senate districts in descending order is found in **Appendix C**. A comparative map of total expenditures by senate district is shown below in **Figure 2**.

² Approximately \$300,000 in independent expenditures were reported as non-itemized, which means that the candidate who was supported or opposed by the independent expenditure is not disclosed.



Comparative charts on the campaign expenditures and independent expenditures made by each candidate in each house district is provided in **Appendix A**. A similar set of charts for each candidate in each senate district is available in **Appendix B**.

2020 Independent Expenditures




Figure 4 Minnesota Independent Expenditures by Election Year 1994 - 2020

Comparing candidate campaign expenditures and independent expenditures over multiple elections is complicated by the fact that total campaign expenditures and independent expenditures increase or decrease depending on which offices are on the ballot. In particular, the presence of the office of governor on the ballot significantly increases the total amount of spending on independent expenditures. In **Figure 4**, the total amount of independent expenditures spikes in 2006, 2010, 2014, and 2018, which are the years in which the office of governor was up for election. However, a direct comparison between the years when the office of governor is on the ballot is still problematic because of the office of state senate, which may or may not match when the governor is on the ballot. Therefore, while it is possible to say that total spending on independent expenditures has steadily increased over time, the increase is not strictly linear as the amount varies in relation to the offices on the ballot. In 2020, both the House and the Senate were on the ballot, but the office of governor and the other constitutional offices were not.

Figure 4 also breaks out independent expenditures by the type of registered committee that made the expenditure: political party units, political committees and funds, and independent expenditure committees and funds. Independent expenditure committees and funds are different from other political committees and funds because they may accept contributions from corporations. The 2010 election is the first year during which independent expenditure committees and funds were recognized under Minnesota law. Expenditures by independent expenditure committees and funds are shown in blue.





Figure 5 Campaign Expenditures and Independent Expenditures by Office and Party

In 2020 independent expenditures were in total significantly higher for races in the state senate (\$18,287,160) than for races in the state house (\$7,963,556). By political party, the majority of independent expenditures were made either in support of DFL candidates or in opposition to RPM candidates³. In **Figure 5** campaign expenditures and independent expenditures for and against candidates by office and party are compared.

As mentioned above, independent expenditures are not equally spread among all districts. In **Figure 6** the sixteen senate districts shaded in green are those districts in which independent expenditures exceeded candidate campaign expenditures. The same is true for the thirty-one house districts in **Figure 7**. The insert in both maps are the metro area districts. Similar to the 2018 state election, the suburban legislative districts in which independent expenditures exceeded candidate expenditures making nearly a complete circle around Minneapolis and St. Paul. In 2020 independent expenditures for house districts were also prominent in the northeast quarter of the state.

³ Some independent expenditures are made prior to the primary election and are made to support or oppose a candidate of the same political party. This somewhat distorts the party breakdown in figure 3, but independent spending to influence a primary election result is a relatively small amount of total independent expenditures.

Figure 6 Independent Expenditures Compared to Candidate Expenditures in Senate Districts




Independent expenditures in the sixteen senate districts shown in green in **Figure 6** total \$17,429,195 compared to a total of \$2,594,607 in campaign expenditures spent in those districts. In the districts where independent expenditures exceeded candidate expenditures approximately 6.7 dollars were spent on independent expenditures for every dollar spent in total by candidate committees.

In **Figure 7**, in the thirty-one house districts shown in green a total of \$7,472,606 was spent on independent expenditures, compared to \$2,694,581 in campaign expenditures by candidate committees in those districts. In the districts where independent expenditures exceeded candidate expenditures 2.75 dollars were spent on independent expenditures for every dollar spend in total by candidate committees.


Independent Expenditures Compared to Candidate Expenditures in House Districts



Sources of Funding for Legislative Candidates in 2019 - 2020




Figure 8 Source of Funding for Legislative Candidates 2019 – 2020

During the two-year period of 2019 – 2020 legislative candidate committees received \$17,058,434 in funding from contributions from individuals, political party units, political committees and funds, and lobbyists, plus an additional \$2,131,750 in direct public subsidy payments. In **Figure 8** the source of funding for legislative candidates is compared by office and DFL and RPM affiliation. Contributions to legislative candidates affiliated with a political party other than DFL or RPM were either from individuals (\$13,493) or political parties (\$2,600). No legislative candidate affiliated with a political party other than the DFL or RPM qualified for a public subsidy payment.

Sources of Funding for Political Parties

During the two-year period of 2019 – 2020 the RPM and DFL political parties received \$39,269,749 in funding from contributions from individuals, political party units, political committees and funds, associations not registered with the Board, and lobbyists.⁴ In **Figure 9** the source of funding for DFL and RPM party units are compared. The contributions from party units generally represent transfers from local party units or legislative caucuses to the state central committees. Arguably, party unit transfers represent a double counting of contribution dollars received by party units and inflate the total funds actually received by political parties in Minnesota.







⁴ During 2019 – 2020 the DFL and RPM parties also received \$124,951 in public subsidy payments. That total is not included in figure 7 because the amount is significantly less than 1% of the total funding.

During the years 2019 and 2020 the Independence-Alliance Party, Grassroots-Legalize Cannabis Party, Legal Marijuana Now Party, and Libertarian Party received a total or \$119,975 in contributions, almost exclusively from individuals.

Source of Funding for Political Committees and Political Funds, and Independent Expenditure Committees and Funds

In addition to the sources of funding available to regular political committees and political funds, independent expenditure committees and independent expenditure funds may accept corporate contributions. The corporate contributions may be provided directly to the independent committee or fund, or corporate funding may be indirectly provided through a contribution from an association that receives corporate funding. As seen in **Figure 10**, direct contributions to independent expenditure committees and funds from for-profit corporations seldom occurs, with only \$1,500 received in 2019 and 2020.





Both regular political committees and funds and independent expenditure committees and funds receive a significant portion of their funding from unregistered associations, which are associations not registered with the Board. However, the unregistered associations that contribute to regular committees and funds are often very different from the unregistered associations that contribute to independent expenditure committees and funds. Additionally, the underlying source disclosure required for contributions received from unregistered associations is significantly different and less revealing for independent expenditure committees and funds.

A regular political committee that receives a contribution of over \$200 from an unregistered association must acquire a disclosure statement from the association and provide the statement to the Board. The statement must be very similar to the disclosure report required under Chapter 10A for registered committees. Generally, an unregistered association that contributes to a political committee will be registered with the Federal Election Commission, or in another state. A regular political fund may also receive contributions from unregistered associations with the appropriate disclosure, and may also receive a transfer of membership dues from individuals from supporting organizations without underlying disclosure. Typically, this will be in the form of membership dues from labor unions or trade associations.

In comparison, independent expenditure committees and funds only need an underlying disclosure statement if the unregistered association has donated over \$5,000 in Minnesota during the calendar year. The disclosure statement for contributions to independent expenditure committees and funds is narrowly tailored to provide information only on the money used for the contribution, not the entire source of funding for the unregistered association. For donations to independent expenditure committees and funds the unregistered association only has to disclose sources of funds used for the donation in Minnesota if the funds were specifically designated for use in making the donation, or list sources of funding if a pro rata calculation of all unrestricted funding available to the association results in a source of funding providing over \$5,000 attributable to the Minnesota donation.

In **Figure 11** the source of funding for contributions to independent expenditure committees and funds provided on statements of underlying disclosure in 2020 is graphed. Of the \$12,356,529 in contributions that required underlying disclosure the underlying disclosure statement provided no itemization of the source of contributions was provided 58% of the time, another unregistered association was identified as the source of funding for the contribution 37% of the time, business revenue was identified as the source of funding for the contribution for 3% of the contributions, and individuals were identified as the source of funding for the contribution 2% of the time.



Disclosure of Funding Provided by Unregistered Associations for Contributions to Independent Expenditure Committees and Funds in 2020


The Role of Large Contributions in Funding Political Committees, Political Funds, and Political Party Units

Any individual or association that contributes more than \$200 during a year to a single recipient is itemized on disclosure reports filed by political party units and political committees and funds.⁵ The total amount of itemized contributions received by political committees, political funds, and political party units from all sources in 2019 and 2020 came to \$103,496,223. Political party units, political committees, and political funds do not have limits on the size of contributions that may be received.


⁵ The itemization threshold for contributions received by ballot question committees and funds is \$500. However, no ballot question committee or fund has reported receiving a contribution since 2013.


Therefore, individuals who are able to contribute large amounts to party units and political committees become an important funding source.

In **Figure 12** the relative importance of individuals who each contributed \$50,000 or more in aggregate during 2019 and 2020 is compared to all other itemized donations from individuals. The 68 individuals who contributed more than \$50,000 during those two years provided \$14,364,099 in funding; more than the other 6,543 itemized individual contributors combined, who provided \$10,201,314 in funding.




The importance of large contributors is also shown when comparing contributions from all sources (including individuals) of over \$50,000 received to the total contributions received from all sources that contributed less than \$50,000 during the two-year period. As shown in **Figure 13** the 217 donors who contributed over \$50,000 provided 82% of total funding received during 2019 and 2020.







